## A BILL

To amend title 36, United States Code, to authorize a grant to protect young athletes from abuse, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Keep Young Athletes  
5 Safe Act of 2018”.

1 **SEC. 2. GRANT TO PROTECT YOUNG ATHLETES FROM**  
2 **ABUSE.**

3 (a) IN GENERAL.—Chapter 2205 of title 36, United  
4 States Code, is amended by adding at the end the fol-  
5 lowing:

6 “SUBCHAPTER III—GRANT TO KEEP YOUNG  
7 ATHLETES SAFE

8 “§ 220531. **Grant to protect young athletes from abuse**

9 “(a) AUTHORITY.—The Attorney General may award  
10 a grant to an eligible nonprofit nongovernmental entity in  
11 order to support oversight of the United States Olympic  
12 Committee, each national governing body, and each  
13 paralympic sports organization with regard to safe-  
14 guarding amateur athletes against abuse, including emo-  
15 tional, physical, and sexual abuse in sports.

16 “(b) APPLICATIONS.—To be eligible to receive a  
17 grant under this section, a nonprofit nongovernmental en-  
18 tity shall submit an application to the Attorney General  
19 at such time, in such manner, and containing such infor-  
20 mation as the Attorney General may require, including in-  
21 formation that demonstrates that the entity has—

22 “(1) nationally recognized expertise in pre-  
23 venting and investigating emotional, physical, and  
24 sexual abuse in the athletic programs of the United  
25 States Olympic Committee, each national governing  
26 body, and each paralympic sports organization; and

1           “(2) the capacity to oversee regular and ran-  
2           dom audits to ensure that the policies and proce-  
3           dures used by the United States Olympic Com-  
4           mittee, each national governing body, and each  
5           paralympic sports organization to prevent the abuse  
6           of an amateur athlete are followed correctly.

7           “(c) USE OF GRANT AMOUNT.—An entity that re-  
8           ceives a grant under this section may use such funds—

9           “(1) to develop and test new training materials  
10          for emotional, physical, and sexual abuse prevention  
11          education in youth athletic programs;

12          “(2) for staff salaries, travel expenses, equip-  
13          ment, printing, and other reasonable expenses nec-  
14          essary to develop, maintain, and disseminate to the  
15          United States Olympic Committee, each national  
16          governing body, each paralympic sports organization,  
17          and other amateur sports organizations information  
18          about safeguarding amateur athletes against abuse,  
19          including emotional, physical, and sexual abuse in  
20          sports; and

21          “(3) to oversee the administration of the proce-  
22          dures described in subsection (b)(2).

23          “(d) AUTHORIZATION OF APPROPRIATIONS.—

1           “(1) IN GENERAL.—There is authorized to be  
2           appropriated to carry out this section \$2,500,000 for  
3           each of the fiscal years 2018 through 2022.

4           “(2) AVAILABILITY OF GRANT FUNDS.—Funds  
5           appropriated under this section shall remain avail-  
6           able until expended.”.

7           (b) CLERICAL AMENDMENT.—The table of sections  
8           for chapter 2205 of title 36, United States Code, is  
9           amended by inserting after the item related to section  
10          220529 the following:

                  “SUBCHAPTER III—GRANT TO KEEP YOUNG ATHLETES SAFE  
                  “220531. Grant to protect young athletes from abuse.”.
