- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Treating Barriers to
- 3 Prosperity Act of 2018".
- 4 SEC. 2. DRUG ABUSE MITIGATION INITIATIVE.
- 5 (a) In General.—Chapter 145 of title 40, United
- 6 States Code, is amended by inserting after section 14509
- 7 the following:

8 "§ 14510. Drug abuse mitigation initiative

- 9 "(a) IN GENERAL.—The Appalachian Regional Com-
- 10 mission may provide technical assistance to, make grants
- 11 to, enter into contracts with, or otherwise provide amounts
- 12 to individuals or entities in the Appalachian region for
- 13 projects and activities to address drug abuse, including
- 14 opioid abuse, in the region, including projects and activi-
- 15 ties—
- 16 "(1) to facilitate the sharing of best practices
- among States, counties, and other experts in the re-
- gion with respect to reducing such abuse;
- "(2) to initiate or expand programs designed to
- eliminate or reduce the harm to the workforce and
- economic growth of the region that results from such
- abuse;
- 23 "(3) to attract and retain relevant health care
- 24 services, businesses, and workers; and

1	"(4) to develop relevant infrastructure, includ-
2	ing broadband infrastructure that supports the use
3	of telemedicine.
4	"(b) Limitation on Available Amounts.—Of the
5	cost of any activity eligible for a grant under this sec-
6	tion—
7	"(1) not more than 50 percent may be provided
8	from amounts appropriated to carry out this section;
9	and
10	"(2) notwithstanding paragraph (1)—
11	"(A) in the case of a project to be carried
12	out in a county for which a distressed county
13	designation is in effect under section 14526,
14	not more than 80 percent may be provided from
15	amounts appropriated to carry out this section;
16	and
17	"(B) in the case of a project to be carried
18	out in a county for which an at-risk designation
19	is in effect under section 14526, not more than
20	70 percent may be provided from amounts ap-
21	propriated to carry out this section.
22	"(c) Sources of Assistance.—Subject to sub-
23	section (b), a grant provided under this section may be
24	provided from amounts made available to carry out this
25	section in combination with amounts made available—

- 1 "(1) under any other Federal program (subject
- 2 to the availability of subsequent appropriations); or
- 3 "(2) from any other source.
- 4 "(d) Federal Share.—Notwithstanding any provi-
- 5 sion of law limiting the Federal share under any other
- 6 Federal program, amounts made available to carry out
- 7 this section may be used to increase that Federal share,
- 8 as the Appalachian Regional Commission determines to be
- 9 appropriate.".
- 10 (b) CLERICAL AMENDMENT.—The analysis for chap-
- 11 ter 145 of title 40, United States Code, is amended by
- 12 inserting after the item relating to section 14509 the fol-
- 13 lowing:

"14510. Drug abuse mitigation initiative.".
