A BILL

To amend the Food and Nutrition Act of 2008 to remove the ineligibility of individuals who participate in a strike.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Worker Eligibility
5 Fairness Act of 2011”.

6 **SEC. 2. AMENDMENTS.**

7 (a) ELIGIBILITY DISQUALIFICATIONS.—Section 6(d)
8 of the Food and Nutrition Act of 2008 (7 U.S.C. 2015(d))
9 is amended—

10 (1) in paragraph (1)(D) by striking clause (iv),

1 (2) by striking paragraph (3), and
2 (3) by redesignating paragraph (4) as para-
3 graph (3).

4 (b) CONFORMING AMENDMENTS.—

5 (1) ELIGIBLE HOUSEHOLDS.—Section 5 of the
6 Food and Nutrition Act of 2008 (7 U.S.C. 2014) is
7 amended—

8 (A) in subsection (d)(14) by striking “sec-
9 tion 6(d)(4)(I)” and inserting “section
10 6(d)(3)(I)”, and

11 (B) in subsection (e)(3)(B)(iii) by striking
12 “section 6(d)(4)” and inserting “section
13 6(d)(3)”.

14 (2) ADMINISTRATION.—Section 11(e)(19) of
15 the Food and Nutrition Act of 2008 (7 U.S.C.
16 2020(e)(19)) is amended by striking “section
17 6(d)(4)” and inserting “section 6(d)(3)”.

18 (3) ADMINISTRATIVE COST-SHARING AND QUAL-
19 ITY CONTROL.—Section 16(h) of the Food and Nu-
20 trition Act of 2008 (7 U.S.C. 2025(h)) is amend-
21 ed—

22 (A) in paragraph (3)—

23 (i) by striking “section 6(d)(4)” and
24 inserting “section 6(d)(3)”, and

1 (ii) by striking “section
2 6(d)(4)(I)(i)(II)” and inserting “section
3 6(d)(3)(I)(i)(II”),

4 (B) in paragraph (4) by striking “section
5 6(d)(4)” and inserting “section 6(d)(3)”, and

6 (C) in paragraph (5) by striking “section
7 6(d)(4)” and inserting “section 6(d)(3)”.

8 (4) MINNESOTA FAMILY INVESTMENT
9 PROJECT.—Section 22(b)(4) of the Food and Nutri-
10 tion Act of 2008 (7 U.S.C. 2032(b)(4)) is amended
11 by striking “section 6(d)(4)” and inserting “section
12 6(d)(3)”.

13 **SEC. 3. EFFECTIVE DATE; APPLICATION OF AMENDMENTS.**

14 (a) EFFECTIVE DATE.—Except as provided in sub-
15 section (b), this Act and the amendments made by this
16 Act shall take effect upon the Act’s passage into law.

17 (b) APPLICATION OF AMENDMENTS.—The amend-
18 ments made by this Act shall not apply with respect to
19 certification periods that begin before the Act’s passage
20 into law.
