## A BILL

To clarify that the Secretary of Health and Human Services has authority to implement a residential eviction moratorium under the quarantine authority vested by the Public Health Service Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Keeping Renters Safe  
3 Act of 2021”.

4 **SEC. 2. CLARIFICATION HHS HAS AUTHORITY FOR RESI-  
5 DENTIAL EVICTION MORATORIA.**

6 Section 361 of the Public Health Service Act (42  
7 U.S.C. 264) is amended—

8 (1) by redesignating subsection (e) as sub-  
9 section (f); and

10 (2) by inserting after subsection (d) the fol-  
11 lowing:

12 “(e) Consistent with the standard described in sub-  
13 section (a), regulations under this section may implement,  
14 maintain, or extend a residential eviction moratorium.”.

15 **SEC. 3. COVID-19 EVICTION MORATORIUM.**

16 (a) IN GENERAL.—The Secretary of Health and  
17 Human Services shall implement a national residential  
18 eviction moratorium under section 361 of the Public  
19 Health Service Act (42 U.S.C. 264) to reduce the intro-  
20 duction, transmission, and spread of COVID-19 and oth-  
21 erwise address the public health emergency declared under  
22 section 319 of the such Act (42 U.S.C. 247d) with respect  
23 to COVID-19.

24 (b) APPLICABILITY.—The moratorium under sub-  
25 section (a) shall—

1           (1) be automatic, without requiring individuals  
2           to apply for coverage; and

3           (2) apply to all residential eviction filings, hear-  
4           ings, judgments, and execution of judgments, except  
5           that the Secretary of Health and Human Services  
6           may establish moratorium exceptions necessary to  
7           protect the health and safety of others.

8           (c) PERIOD FOLLOWING PUBLIC HEALTH EMER-  
9           GENCY.—The moratorium under subsection (a) shall re-  
10          main in effect at least 60 days after the conclusion of the  
11          public health emergency described in such subsection, in-  
12          cluding any extensions thereof.
