## A BILL

To prevent allocations of Special Drawing Rights at the International Monetary Fund for countries that are perpetrators of genocide or state sponsors of terrorism, and to prevent United States tax dollars from directly going to the Taliban or other terrorists or terrorist-harboring nations.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “No Support for Terror  
3 Act”.

4 **SEC. 2. PREVENTING ALLOCATIONS OF SPECIAL DRAWING**  
5 **RIGHTS AT THE INTERNATIONAL MONETARY**  
6 **FUND FOR COUNTRIES THAT ARE PERPETRA-**  
7 **TORS OF GENOCIDE OR STATE SPONSORS OF**  
8 **TERRORISM.**

9 The Bretton Woods Agreements Act (22 U.S.C. 286  
10 et seq.) is amended by adding at the end the following:

11 **“SEC. 74. PREVENTING ALLOCATIONS OF SPECIAL DRAW-**  
12 **ING RIGHTS FOR COUNTRIES THAT ARE PER-**  
13 **PETRATORS OF GENOCIDE OR STATE SPON-**  
14 **SORS OF TERRORISM.**

15 “The Secretary of the Treasury shall instruct the  
16 United States Executive Director at the Fund to use the  
17 voice and vote of the United States to—

18 “(1) oppose the allocation of Special Drawing  
19 Rights to any country that is a perpetrator of geno-  
20 cide or a state sponsor of terrorism, as determined  
21 by the Secretary of State; and

22 “(2) advocate that the Fund adopt a rule pro-  
23 hibiting such an allocation.”.

1 **SEC. 3. PREVENTING UNITED STATES TAX DOLLARS FROM**  
2 **BEING PROVIDED TO THE TALIBAN OR**  
3 **OTHER TERRORIST ORGANIZATIONS OR**  
4 **COUNTRIES THAT HARBOR TERRORIST OR-**  
5 **GANIZATIONS.**

6 (a) REVIEW.—

7 (1) IN GENERAL.—The Secretary of the Treas-  
8 ury, the Secretary of State, and the Administrator  
9 of the United States Agency for International Devel-  
10 opment shall jointly conduct a review of assistance  
11 provided to nongovernmental organizations and  
12 international organizations to ensure such assistance  
13 is not being further provided to the Taliban or other  
14 terrorist organizations or countries that harbor ter-  
15 rorist organizations in accordance with United  
16 States anti-terrorism financing laws.

17 (2) REPORT.—Not later than 90 days after the  
18 date of the enactment of this Act, the Secretary of  
19 the Treasury, the Secretary of State, and the Ad-  
20 ministrator of the United States Agency for Inter-  
21 national Development shall jointly submit to Con-  
22 gress a report that contains the results of the review  
23 conducted under paragraph (1).

24 (b) RECIPIENT REQUIREMENTS.—Not later than 180  
25 days after the date of the enactment of this Act, the Sec-  
26 retary of the Treasury, the Secretary of State, and the

1 Administrator of the United States Agency for Inter-  
2 national Development shall each require prime awardees  
3 of assistance to provide evidence that all sub-awardees of  
4 such assistance are complying with United States anti-ter-  
5 rorism financing laws.
