Mr. ROYCE (for himself and Ms. HAHN) introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To amend title 38, United States Code, to ensure that the Secretary of Veterans Affairs is informed of the interment of deceased veterans, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterans Dignified
5 Burial Act”.

1 **SEC. 2. INFORMATION CONCERNING SCHEDULED INTER-**
2 **MENTS OF VETERANS.**

3 (a) IN GENERAL.—Chapter 24 of title 38, United
4 States Code, is amended by adding at the end the fol-
5 lowing new section:

6 **“§ 2415. Information concerning scheduled inter-**
7 **ments**

8 “(a) SCHEDULED INTERMENT.—At the same time
9 that the Secretary confirms to a covered entity the veteran
10 status of a deceased veteran in the custody of the covered
11 entity, the Secretary shall request from the covered entity
12 the specific date of the scheduled interment of the de-
13 ceased veteran. During each 30-day period following the
14 date of such request, the Secretary shall repeat such re-
15 quest until the date on which the covered entity confirms
16 to the Secretary that the deceased veteran has been in-
17 terred.

18 “(b) ANNUAL REPORT.—Not later than January 31
19 of each year, the Secretary shall submit to the Committees
20 on Veterans’ Affairs of the House of Representatives and
21 the Senate a report on deceased veterans who were in-
22 terred after the 30-day period following the date on which
23 the Secretary made a request under subsection (a). Such
24 report shall include—

25 “(1) during the year prior to the year in which
26 the report is submitted, the number of deceased vet-

1 erans who were not interred during such period, in-
2 cluding the covered entity that had custody of each
3 deceased veteran; and

4 “(2) the number of such deceased veterans who,
5 as of the date of the report, are not yet interred, in-
6 cluding the covered entity that has custody of each
7 deceased veteran.

8 “(c) COVERED ENTITY DEFINED.—In this section,
9 the term ‘covered entity’ means a local medical examiner,
10 funeral director, county service group, or other similar en-
11 tity.”.

12 (b) CLERICAL AMENDMENT.—The table of sections
13 at the beginning of such chapter is amended by inserting
14 after the item relating to section 2414 the following new
15 item:

“2415. Information concerning scheduled interments.”.
