## A BILL

To amend the Clayton Act and the Federal Trade Commission Act to provide that the Federal Trade Commission shall exercise authority with respect to mergers only under the Clayton Act and only in the same procedural manner as the Attorney General exercises such authority.

1       *Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Standard Merger and  
5 Acquisition Reviews Through Equal Rules Act of 2014”.

6 **SEC. 2. AMENDMENTS TO THE CLAYTON ACT.**

7       The Clayton Act (15 U.S.C. 12 et seq.) is amended—

5                             (3) in section 11(a) by inserting “(excluding en-

7                             merce”,

8                             (4) in section 13 by inserting “(including the

10                             tion of section 7)” after “United States” the 1st  
11                             place it appears, and

12                             (5) in section 15 by inserting “and the duty of  
13                             the Federal Trade Commission with respect to a vio-  
14                             lation of section 7,” after “General.”.

15 **SEC. 3. AMENDMENTS TO THE FEDERAL TRADE COMMI-**  
16 **SION ACT.**

17                             The Federal Trade Commission Act (15 U.S.C. 41)  
18                             is amended—

19                             (1) in section 5(b)—

20                                 (A) by inserting “(excluding the con-  
21                             summation of a proposed merger, acquisition,  
22                             joint venture, or similar transaction subject to  
23                             section 7 of the Clayton Act)” after “unfair  
24                             method of competition”, and

1                             (B) by inserting “(excluding the con-  
2                             summation of a proposed merger, acquisition,  
3                             joint venture, or similar transaction subject to  
4                             section 7 of the Clayton Act)” after “method of  
5                             competition” the 2d and 3d places it appears,  
6                             (2) in section 9 by inserting after the 4th un-  
7                             designated paragraph the following:

8                             “Upon the application of the commission with respect  
9                             to any activity related to the consummation of a proposed  
10                           merger, acquisition, joint venture, or similar transaction  
11                           subject to section 7 of the Clayton Act that may result  
12                           in any unfair method of competition, the district courts  
13                           of the United States shall have jurisdiction to issue writs  
14                           of mandamus commanding any person or corporation to  
15                           comply with the provisions of this Act or any order of the  
16                           commission made in pursuance thereof.”, and

17                             (3) in section 13(b)(1) by inserting “(excluding  
18                             section 7 of the Clayton Act and section 5(a)(1) with  
19                             respect to the consummation of a proposed merger,  
20                             acquisition, joint venture, or similar transaction sub-  
21                             ject to section 7 of the Clayton Act)” after “Com-  
22                             mission”.

23 **SEC. 4. EFFECTIVE DATE; APPLICATION OF AMENDMENTS.**

24                             (a) EFFECTIVE DATE.—Except as provided in sub-  
25                             section (b), this Act and the amendments made by this

1 Act shall take effect on the date of the enactment of this  
2 Act.

3 (b) APPLICATION OF AMENDMENTS.—The amend-  
4 ments made by this Act shall not apply to any of the fol-  
5 lowing that occurs before the date of enactment of this  
6 Act:

7 (1) A violation of section 7 of the Clayton Act  
8 (15 U.S.C. 18).

9 (2) A transaction with respect to which there is  
10 compliance with section 7A of the Clayton Act (15  
11 U.S.C. 18a).

12 (3) A merger, acquisition, joint venture, or  
13 similar transaction that is consummated.
