## A BILL

To repeal the Office of Financial Research, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REPEAL OF THE OFFICE OF FINANCIAL RE-**  
4 **SEARCH.**

5 (a) IN GENERAL.—Subtitle B of title I of the Dodd-  
6 Frank Wall Street Reform and Consumer Protection Act  
7 (12 U.S.C. 5342) is hereby repealed.

8 (b) CONFORMING AMENDMENTS TO THE DODD-  
9 FRANK WALL STREET REFORM AND CONSUMER PROTEC-  
10 TION ACT.—The Dodd-Frank Wall Street Reform and

1 Consumer Protection Act (12 U.S.C. 5301 et seq.) is  
2 amended—

3 (1) in the table of contents in section 1(b), by  
4 striking the items relating to subtitle B of title I;

5 (2) in section 102(a)—

6 (A) by striking paragraph (5); and

7 (B) by redesignating paragraphs (6) and  
8 (7) as paragraphs (5) and (6), respectively;

9 (3) in section 111—

10 (A) in subsection (b)(2)—

11 (i) by striking subparagraph (A); and

12 (ii) by redesignating subparagraphs  
13 (B) through (E) as subparagraphs (A)  
14 through (D), respectively; and

15 (B) in subsection (c)(1), by striking “sub-  
16 paragraphs (C), (D), and (E)” and inserting  
17 “subparagraphs (B), (C), and (D)”;

18 (4) in section 112—

19 (A) in subsection (a)(2)—

20 (i) in subparagraph (A), by striking  
21 “direct the Office of Financial Research  
22 to”;

23 (ii) by striking subparagraph (B); and

1 (iii) by redesignating subparagraphs  
2 (C) through (N) as subparagraphs (B)  
3 through (M), respectively; and

4 (B) in subsection (d)—

5 (i) in paragraph (1), by striking “the  
6 Office of Financial Research, member  
7 agencies, and” and inserting “member  
8 agencies and”;

9 (ii) in paragraph (2), by striking “the  
10 Office of Financial Research, any member  
11 agency, and” and inserting “any member  
12 agency and”;

13 (iii) in paragraph (3)—

14 (I) by striking “, acting through  
15 the Office of Financial Research,”  
16 each place such term appears; and

17 (II) in subparagraph (B), by  
18 striking “the Office of Financial Re-  
19 search or”;

20 (iv) in paragraph (5)(A), by striking  
21 “, the Office of Financial Research,”;

22 (5) in section 116, by striking “, acting through  
23 the Office of Financial Research,” each place such  
24 term appears; and

25 (6) by amending section 118 to read as follows:

1 **“SEC. 118. COUNCIL FUNDING.**

2 “There is authorized to be appropriated to the Coun-  
3 cil \$4,000,000 for fiscal year 2018 and each fiscal year  
4 thereafter to carry out the duties of the Council.”.

5 (c) **ADDITIONAL CONFORMING AMENDMENTS.—**

6 (1) **FINANCIAL INSTITUTIONS REFORM, RECOV-**  
7 **ERY, AND ENFORCEMENT ACT OF 1989.—**Section  
8 1206(a) of the Financial Institutions Reform, Recov-  
9 ery, and Enforcement Act of 1989 (12 U.S.C.  
10 1833b(a)) is amended by striking “the Office of Fi-  
11 nancial Research,”.

12 (2) **TITLE 5.—**Title 5, United States Code, is  
13 amended—

14 (A) in section 3132(a)(1)(D), by striking  
15 “the Bureau of Consumer Financial Protection,  
16 and the Office of Financial Research” and in-  
17 serting “and the Bureau of Consumer Financial  
18 Protection”; and

19 (B) in section 5314, by striking “Director  
20 of the Office of Financial Research.”.

21 (3) **TITLE 44.—**Section 3502(5) of title 44,  
22 United States Code, is amended by striking “the Of-  
23 fice of Financial Research,”.
