A BILL

To redesignate the Jimmy Carter National Historic Site as the “Jimmy Carter National Historical Park”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Jimmy Carter National
5 Historical Park Redesignation Act”.

1 **SEC. 2. DESIGNATION OF JIMMY CARTER NATIONAL HIS-**
2 **TORICAL PARK.**

3 (a) IN GENERAL.—The Jimmy Carter National His-
4 toric Site shall be known and designated as the “Jimmy
5 Carter National Historical Park”.

6 (b) AMENDMENTS TO PUBLIC LAW 100–206.—Pub-
7 lic Law 100–206 (54 U.S.C. 320101 note; 101 Stat.
8 1434) is amended—

9 (1) in section 1(a), in the matter preceding
10 paragraph (1), by striking “National Historic Site”
11 and inserting “National Historical Park”;

12 (2) in section 3—

13 (A) in subsection (a), by striking “provi-
14 sions of law generally applicable to national his-
15 toric sites” and inserting “provisions of law
16 generally applicable to units of the National
17 Park System”; and

18 (B) in subsection (d), in the second sen-
19 tence, by striking “National Historic Site” and
20 inserting “National Historical Park”;

21 (3) in section 6(2), by striking “National His-
22 toric Site” and inserting “National Historical
23 Park”;

24 (4) by striking “historic site” each place it ap-
25 pears and inserting “historical park”;

1 (5) by striking “historic site” each place it ap-
2 pears and inserting “historical park”; and

3 (6) by striking “Historic Site” each place it ap-
4 pears and inserting “Historical Park”.

5 (c) REFERENCES.—Any reference in any law, regula-
6 tion, document, record, map, or other paper of the United
7 States to the Jimmy Carter National Historic Site shall
8 be considered to be a reference to the “Jimmy Carter Na-
9 tional Historical Park”.
