## A BILL

To amend the Richard B. Russell National School Lunch Act with respect to reimbursements under the child and adult care food program, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Child Care Nutrition  
5 Enhancement Act of 2023”.

6 **SEC. 2. REIMBURSEMENTS UNDER CACFP PROGRAM.**

7       (a) ADDITIONAL REIMBURSEMENTS.—Section 17 of  
8 the Richard B. Russell National School Lunch Act (42  
9 U.S.C. 1766) is amended—

1                             (1) in subsection (c)—

2                                 (A) in paragraphs (1), (2), and (3), by in-  
3                                 serting “and subject to paragraph (7)” after  
4                                 “subsection (f)(3)” each place it appears; and

5                                 (B) by adding at the end the following:

6                                 “(7) ADDITIONAL REIMBURSEMENT.—Beginning on  
7                                 the first day of the first month that begins after the date  
8                                 of the enactment of this paragraph, each meal and supple-  
9                                 ment served under this section shall receive an additional  
10                                reimbursement in the amount of 10 cents (as adjusted  
11                                pursuant to section 11(a) of this Act).”;

12                                 (2) in subsection (f)(2)(A), by striking “multi-  
13                                 plying the” and all that follows through the period  
14                                 at the end and inserting the following: “multi-  
15                                 plying—

16                                 “(i) the total number of each type of  
17                                 meal (breakfast, lunch, or supper) or sup-  
18                                 plement served in such institution in that  
19                                 fiscal year, by

20                                 “(ii) the sum obtained by adding the  
21                                 applicable national average payment rate  
22                                 for each such type of meal or supplement,  
23                                 as determined under subsection (c), to the  
24                                 additional reimbursement amount required  
25                                 under paragraph (7) of such subsection.”;

1                         (3) in subsection (o)(3)(A), by inserting “(in-  
2                         cluding the additional reimbursement amount re-  
3                         quired under subsection (c)(7))” before the period at  
4                         the end;

5                         (4) in subsection (r)(4)(B)—

6                             (A) in clause (i), by inserting “plus the ad-  
7                         ditional reimbursement amount required under  
8                         paragraph (7) of such subsection” before the  
9                         period at the end; and

10                         (B) in clause (ii), by inserting “plus the  
11                         additional reimbursement amount required  
12                         under subsection (c)(7)” before the period at  
13                         the end; and

14                         (5) in subsection (t)(5)(B), by inserting “plus  
15                         the additional reimbursement amount required  
16                         under paragraph (7) of such subsection” before the  
17                         period at the end.

18                         (b) REIMBURSEMENT OF FAMILY OR GROUP DAY  
19 CARE HOME SPONSORING ORGANIZATIONS.—Section  
20 17(f)(3) of the Richard B. Russell National School Lunch  
21 Act (42 U.S.C. 1766(f)(3)) is amended—

22                         (1) in subparagraph (A)—

23                             (A) in clause (ii)—

1                             (i) by amending the heading to read  
2                             as follows “CALCULATION OF REIMBURSE-  
3                             MENT”;

4                             (ii) by striking subclause (I);  
5                             (iii) by redesignating subclauses (II),  
6                             (III), and (IV) as subclauses (I), (II), and  
7                             (III), respectively;

8                             (iv) in subclause (I), as so redesign-  
9                             nated—

10                             (I) by striking “subclause (III), a  
11                             tier I” and inserting “subclause (II),  
12                             a”; and

13                             (II) by striking “, except that”  
14                             and all that follows through “section  
15                             9”;

16                             (v) in subclause (II), as so redesign-  
17                             nated—

18                             (I) by striking “subclause (IV)”  
19                             and inserting “subclause (III)”; and

20                             (II) by striking “subclause (II)”  
21                             and inserting “subclause (I)”; and

22                             (vi) by adding at the end the fol-  
23                             lowing:

24                             “(IV) ADDITIONAL REIMBURSE-  
25                             MENT.—The additional reimburse-

- 1                   ment amount required under sub-  
2                   section (c)(7) shall apply to the reim-  
3                   bursements of meals and supplements  
4                   under this subparagraph.”.  
5                   (B) by striking clause (iii); and  
6                   (2) by striking subparagraph (E).
