- To direct the Secretary of Homeland Security to submit a plan to make Federal assistance available to certain urban areas that previously received Urban Area Security Initiative funding to preserve homeland security capabilities, and for other purposes.

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Homeland Security
- 3 Capabilities Preservation Act".
- 4 SEC. 2. PRESERVATION OF HOMELAND SECURITY CAPA-
- 5 BILITIES.
- 6 (a) Plan.—
- 7 (1) In general.—Not later than one year
- 8 after the date of the enactment of this Act, the Sec-
- 9 retary of Homeland Security, acting through the Ad-
- ministrator of the Federal Emergency Management
- 11 Agency, shall submit to the Committee on Homeland
- 12 Security of the House of Representatives and the
- 13 Committee on Homeland Security and Governmental
- 14 Affairs of the Senate a plan, informed by the survey
- information collected pursuant to subsection (b), to
- make Federal assistance available for at least three
- 17 consecutive fiscal years to certain urban areas that
- in the current fiscal year did not receive grant fund-
- ing under the Urban Area Security Initiative under
- section 2003 of the Homeland Security Act of 2002
- 21 (6 U.S.C. 604) and require continued Federal assist-
- ance for the purpose of preserving a homeland secu-
- 23 rity capability related to preventing, preparing for,
- 24 protecting against, and responding to acts of ter-
- rorism that had been developed or otherwise sup-
- ported through prior grant funding under such Ini-

- tiative and allow for such urban areas to transition
 to such urban areas costs of preserving such homeland security capabilities.
- (2) Additional requirement.—The plan re-5 quired under paragraph (1) shall also contain a pro-6 hibition on an urban area that in a fiscal year is eli-7 gible to receive Federal assistance described in such 8 paragraph from also receiving grant funding under 9 the Urban Area Security Initiative under section 10 2003 of the Homeland Security Act of 2002. In such 11 a case, such plan shall require such an urban area 12 to promptly notify the Administrator of the Federal 13 Emergency Management Agency regarding the pref-14 erence of such urban area to retain either—
- 15 (A) such eligibility for such Federal assist-16 ance; or
- 17 (B) such receipt of such grant funding.
- 18 (b) Survey.—In developing the plan required under 19 subsection (a), the Administrator of the Federal Emer-20 gency Management Agency, shall, to ascertain the scope 21 of Federal assistance required, survey urban areas that—
- 22 (1) did not receive grant funding under the 23 Urban Area Security Initiative under section 2003 24 of the Homeland Security Act of 2002 in the current 25 fiscal year concerning homeland security capabilities

- 1 related to preventing, preparing for, protecting
- 2 against, and responding to acts of terrorism that
- 3 had been developed or otherwise supported through
- 4 funding under such Initiative that are at risk of
- 5 being reduced or eliminated without such Federal
- 6 assistance;
- 7 (2) received such funding in the current fiscal
- 8 year, but did not receive such funding in at least one
- 9 fiscal year in the six fiscal years immediately pre-
- 10 ceding the current fiscal year; and
- 11 (3) any other urban areas the Secretary deter-
- mines appropriate.
- 13 (c) Exemption.—The Secretary of Homeland Secu-
- 14 rity may exempt the Federal Emergency Management
- 15 Agency from the requirements of subchapter I of chapter
- 16 35 of title 44, United States Code (commonly referred to
- 17 as the "Paperwork Reduction Act"), for purposes of car-
- 18 rying out subsection (b) if the Secretary determines that
- 19 complying with such requirements would delay the devel-
- 20 opment of the plan required under subsection (a).
- 21 (d) Contents.—The plan required under subsection
- 22 (a) shall—
- 23 (1) establish eligibility criteria for urban areas
- 24 to receive Federal assistance pursuant to such plan

1	to provide assistance for the purpose described in
2	such subsection;
3	(2) identify annual funding levels for such Fed-
4	eral assistance in accordance with the survey re-
5	quired under subsection (b); and
6	(3) consider a range of approaches to make
7	such Federal assistance available to such urban
8	areas, including—
9	(A) modifications to the Urban Area Secu-
10	rity Initiative under section 2003 of the Home-
11	land Security Act of 2002 in a manner that
12	would not affect the availability of funding to
13	urban areas under such Initiative;
14	(B) the establishment of a competitive
15	grant program;
16	(C) the establishment of a formula grant
17	program; and
18	(D) a timeline for the implementation of
19	any such approach and, if necessary, a legisla-
20	tive proposal to authorize any such approach.
