AN ACT

To require reporting regarding accreditation of basic training programs of the Department of Homeland Security, and for other purposes.

1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "DHS Basic Training
3	Accreditation Improvement Act of 2021".
4	SEC. 2. REPORTING ON BASIC TRAINING PROGRAMS OF
5	THE DEPARTMENT OF HOMELAND SECURITY
6	(a) Annual Reporting.—
7	(1) In general.—Not later than 90 days after
8	the date of the enactment of this Act and annually
9	thereafter, the Secretary of Homeland Security shall
10	report to the relevant congressional committees on
11	the accreditation status for each basic training pro-
12	gram within the Department of Homeland Security,
13	including information relating to the following:
14	(A) The date on which each such program
15	achieved initial accreditation, or in the case of
16	a program that is not currently accredited, the
17	reasons for not obtaining or maintaining ac-
18	creditation, the activities, if any, taken to
19	achieve accreditation, and an anticipated
20	timeline for accreditation of such program.
21	(B) The date each such program most re-
22	cently received accreditation or reaccreditation,
23	if applicable.
24	(C) Each such program's anticipated ac-
25	creditation or next reaccreditation date.

- 1 (D) The name of the accreditation man-2 ager for each such program.
- 3 (2) TERMINATION OF REPORTING REQUIRE-4 MENT.—Annual reports under paragraph (1) shall 5 terminate when all basic training programs of the 6 Department of Homeland Security are accredited.

(b) Lapse in Accreditation.—

- (1) IN GENERAL.—If a basic training program of the Department of Homeland Security loses accreditation, the head of the relevant component of the Department shall notify the Secretary of Homeland Security not later than 30 days after such loss.
- (2) Notice to congress.—Not later than 30 days after receiving a notification pursuant to paragraph (1), the Secretary of Homeland Security shall notify the relevant congressional committees of the lapse in accreditation at issue, the reason for such lapse, and the activities underway and planned to regain accreditation.

(c) Definitions.—In this section:

(1) Accreditation.—The term "accreditation" means the recognition by a board that a basic training program is administered, developed, and delivered according to an applicable set of standards.

- 1 (2) Accreditation manager.—The term "accreditation manager" means the individual assigned
 3 by the component of the Department of Homeland
 4 Security to manage accreditation activities for a
 5 basic training program.
 - (3) Basic training program" means an entry level program of the Department of Homeland Security that is transitional to law enforcement service, provides training on critical competencies and responsibilities, and is typically a requirement for appointment to a law enforcement service job or job series.
 - (4) Reaccreditation.—The term "reaccreditation" means the assessment of a basic training program after initial accreditation to ensure the continued compliance with an applicable set of standards.
 - (5) RELEVANT CONGRESSIONAL COMMITTEES.—The term "relevant congressional committees" means the Committee on Homeland Security and the Committee on the Judiciary of the House of Representatives and the Committee on Homeland Security and Governmental Affairs and the Committee of the Judiciary of the Senate.

1 SEC. 3. RESEARCH AND DEVELOPMENT.

- 2 The Under Secretary for Science and Technology of
- 3 the Department of Homeland Security shall carry out re-
- 4 search and development of systems and technologies to en-
- 5 hance access to training offered by the Federal Law En-
- 6 forcement Training Centers to State, local, Tribal, and
- 7 territorial law enforcement, with particular attention to
- 8 law enforcement in rural and remote communities, for the
- 9 purpose of enhancing domestic preparedness for and col-
- 10 lective response to terrorism and other homeland security
- 11 threats.
