## A BILL

- To authorize the President to establish the Veterans' Job Corps as a means of providing gainful employment to unemployed veterans and widows of veterans through the performance of useful public works, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "Veterans' Job Corps
  - 5 Act".

#### SEC. 2. ESTABLISHMENT AND OPERATION OF VETERANS' 2 JOB CORPS. 3 (a) Establishment and Purpose.—In order to provide employment opportunities to veterans and widows 4 5 and to provide for the restoration of depleted natural resources in the United States and the advancement of an 6 7 orderly program of useful public works, the President may 8 establish and operate a Veterans' Job Corps to employ vet-9 erans and widows who are otherwise unemployed, in the construction, maintenance, and carrying on of works of 10 a public nature in connection with— 11 12 (1) the forestation of lands belonging to the 13 United States or a State; 14 (2) the prevention of forest fires, floods, and 15 soil erosion; 16 (3) public safety; 17 (4) plant pest and disease control; 18 (5) the construction, maintenance, or repair of 19 paths, trails, and fire-lanes in units of the National 20 Park System, public lands, and other lands under 21 the jurisdiction of the Secretary of the Interior and 22 units of the National Forest System; and 23 (6) such other work on Federal or State land 24 incidental to or necessary in connection with any 25 projects of the character enumerated in paragraphs

- 1 (1) through (5) that the President determines to be
- desirable.
- 3 (b) Role of Federal Agencies.—To operate the
- 4 Veterans' Job Corps, the President may use existing Fed-
- 5 eral departments and agencies, including the Department
- 6 of the Interior, the Department of Agriculture, and the
- 7 Department of Veterans Affairs.
- 8 (c) Inclusion of Other Lands.—The President
- 9 may extend the activities of the Veterans' Job Corps to
- 10 lands owned by a political subdivision of a State and lands
- 11 in private ownership for the purpose of conducting such
- 12 kinds of cooperation work authorized by law in preventing
- 13 and controlling forest fires and the attacks of forest tree
- 14 pests and diseases and such work as is necessary and in
- 15 the public interest to control floods.
- 16 (d) Contract Authority.—The President may
- 17 enter into such contracts or agreements that may be nec-
- 18 essary to carry out this Act.
- 19 (e) Acquisition of Real Property.—The Presi-
- 20 dent, or the head of any department or agency authorized
- 21 by the President to construct any project or to carry on
- 22 any public works under this Act, may acquire real prop-
- 23 erty for such project or public work by purchase, donation,
- 24 or otherwise.

#### SEC. 3. ADMINISTRATION OF VETERANS' JOB CORPS.

- 2 (a) Employment Preference.—The President
- 3 shall employ individuals in the Veterans' Job Corps in the
- 4 following order of preference:
- 5 (1) Unemployed veterans.
- 6 (2) Widows who, immediately before employ-
- 7 ment in the Veterans' Job Corps, are eligible for un-
- 8 employment compensation payable under any State
- 9 law or Federal unemployment compensation law, in-
- 10 cluding any additional compensation or extended
- 11 compensation under such laws.
- 12 (b) Housing and Care of Employees.—The
- 13 President may provide housing for individuals employed
- 14 in the Veterans' Job Corps and furnish them with such
- 15 subsistence, clothing, medical attendance and hospitaliza-
- 16 tion, and cash allowance, as may be necessary, during the
- 17 period they are so employed.
- 18 (c) Transportation.—The President may provide
- 19 for the transportation of individuals employed in the Vet-
- 20 erans' Job Corps to and from the places of employment.
- 21 (d) Exclusion.—The following individuals may not
- 22 be employed under the provisions of this Act:
- 23 (1) An individual convicted of a felony.
- 24 (2) A veteran who was discharged from the
- 25 Armed Forces under dishonorable conditions.

### 1 SEC. 4. USE OF FUNDS.

2	(a) Use of Unobligated Funds Appropriated
3	FOR PUBLIC WORKS.—
4	(1) Use of existing funds.—In addition to
5	any amounts appropriated to carry out this Act, the
6	President may use any moneys previously appro-
7	priated for public works and unobligated as of the
8	date of the enactment of this Act to establish and
9	operate a Veterans' Job Corps under this Act.
10	(2) USE TO RELIEVE UNEMPLOYMENT.—Not
11	less than 75 percent of the funds used pursuant to
12	paragraph (1) shall be used to provide for the em-
13	ployment of individuals under this Act.
14	(b) Duration of Availability.—Amounts appro-
15	priated to carry out this Act or made available under sub-
16	section (b) shall remain available until expended.
17	SEC. 5. DEFINITIONS.
18	In this Act:
19	(1) The term "veteran" has the meaning given
20	that term in section 101(2) of title 38, United
21	States Code.
22	(2) The term "widow"—
23	(A) means the spouse of a veteran who has
24	not remarried after the death of such veteran
25	and
26	(B) includes widowers.

#### 1 SEC. 6. TERMINATION.

- 2 The authority of the President to establish and oper-
- 3 ate a Veterans' Job Corps under this Act expires on Sep-

4 tember 30, 2018.
