Mr. CLOUD introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To permit civil actions against the United States for COVID–19 vaccination mandates.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Don’t Jab Me Act”.

5 **SEC. 2. DEFINITIONS.**

6 In this Act:

7 (1) **AGGRIEVED INDIVIDUAL.**—The term “ag-
8 grievied individual” includes—

9 (A) an individual who received a COVID–
10 19 vaccine as a result of Executive Order

1 14043 to prevent the termination, or any other
2 adverse consequence, of the employment of the
3 individual with the Federal agency;

4 (B) an individual who is required to receive
5 a COVID–19 vaccine as a result of Executive
6 Order 14043 to prevent the termination, or any
7 other adverse consequence, of the employment
8 of the individual with the Federal agency;

9 (C) an individual who received a COVID–
10 19 vaccine as a result of a Federal agency re-
11 quirement (or required by their employer who is
12 acting pursuant to a Federal requirement) as a
13 condition of new or continued employment; and

14 (D) an individual who is required by a
15 Federal agency (or required by their employer
16 who is acting pursuant to a Federal require-
17 ment) to receive a COVID–19 vaccine, or be
18 faced with an adverse consequence, as a condi-
19 tion of new or continued employment.

20 (2) EXECUTIVE ORDER 14043.—The term “Ex-
21 ecutive Order 14043” means Executive Order 14043
22 (86 Fed. Reg. 50989; relating to requiring
23 coronavirus disease 2019 vaccination for Federal
24 employees).

1 **SEC. 3. CIVIL ACTIONS AGAINST THE UNITED STATES FOR**
2 **COVID-19 VACCINATION MANDATES.**

3 Any aggrieved individual may commence an action in
4 an appropriate district court of the United States against
5 the United States seeking declaratory or injunctive relief
6 and to recover compensatory damages for injuries sus-
7 tained as a result of a COVID-19 vaccination mandate.

8 **SEC. 4. RULE OF CONSTRUCTION.**

9 Nothing in this Act may be construed to permit or
10 otherwise authorize a COVID-19 vaccine mandate under
11 Federal law (including regulations).
