## A BILL

To amend the Energy Policy Act of 2005 to establish minimum efficiency standards for self-contained commercial refrigerators and freezers, and to direct the Department of Energy to establish standards for other related products.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Better Use of Refrig-  
5 erator Regulations Act”.

1 **SEC. 2. SERVICE OVER THE COUNTER, SELF-CONTAINED,**  
2 **MEDIUM TEMPERATURE COMMERCIAL RE-**  
3 **FRIGERATORS.**

4 Section 342(c) of the Energy Policy and Conservation  
5 Act (42 U.S.C. 6313(c)) is amended—

6 (1) in paragraph (1)—

7 (A) by redesignating subparagraphs (B)  
8 and (C) as subparagraphs (D) and (E), respec-  
9 tively; and

10 (B) by inserting after subparagraph (A)  
11 the following:

12 “(B) The term ‘(SOC-SC-M)’ means a medium  
13 temperature commercial refrigerator—

14 “(i) with a self-contained condensing unit  
15 and equipped with sliding or hinged doors in  
16 the back intended for use by sales personnel,  
17 and with glass or other transparent material in  
18 the front for displaying merchandise; and

19 “(ii) that has a height not greater than 66  
20 inches and is intended to serve as a counter for  
21 transactions between sales personnel and cus-  
22 tomers.

23 “(C) The term ‘TDA’ means the total display  
24 area (ft<sup>2</sup>) of the refrigerated case, as defined in Air-  
25 Conditioning, Heating, and Refrigeration Institute  
26 Standard 1200.”;

1           (2) by redesignating paragraphs (4) and (5) as  
2 paragraphs (5) and (6), respectively; and

3           (3) by inserting after paragraph (3) the fol-  
4 lowing:

5           “(4) Each SOC-SC-M manufactured on or after the  
6 date which is 6 months after the date of enactment of  
7 the Better Use of Refrigerator Regulations Act shall have  
8 a total daily energy consumption (in kilowatt hours per  
9 day) of not more than  $0.6 \times \text{TDA} + 1.0$ .”.
