## A BILL

To prohibit the Secretary of the Treasury from issuing certain licenses in connection with the export or re-export of a commercial passenger aircraft to the Islamic Republic of Iran, to require annual reports by the Secretary of the Treasury and the Export-Import Bank on financing issues related to the sale or lease of such a commercial passenger aircraft or spare parts for such an aircraft, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. EXPORT PROHIBITION.**

2       The Secretary of the Treasury may not issue a license  
3 for the export or re-export of a commercial passenger air-  
4 craft to the Islamic Republic of Iran.

5 **SEC. 2. TREASURY REPORT ON FINANCING.**

6       The Secretary of the Treasury shall issue an annual  
7 report to the Committees on Financial Services and For-  
8 eign Affairs of the House of Representatives and the Com-  
9 mittees on Banking, Housing, and Urban Affairs and For-  
10 eign Relations of the Senate—

11           (1) stating whether any U.S. financial institu-  
12 tion is involved with the sale or lease of commercial  
13 passenger aircraft or spare parts for such aircraft to  
14 the Islamic Republic of Iran by a non-U.S. manufac-  
15 turer, and whether any such involvement is with re-  
16 spect to a commercial passenger aircraft or spare  
17 parts comprising 10 percent or more U.S. content;  
18 and

19           (2) containing a description of the risks related  
20 to repayment, money laundering, and the financing  
21 of terrorism faced by U.S. financial institutions if  
22 they were to be involved in the sale or lease of a  
23 commercial passenger aircraft to the Islamic Repub-  
24 lic of Iran.

1 **SEC. 3. EXPORT-IMPORT BANK REPORT.**

2       The Export-Import Bank shall issue an annual report  
3 to the Committees on Financial Services and Foreign Af-  
4 fairs of the House of Representatives and the Committees  
5 on Banking, Housing, and Urban Affairs and Foreign Re-  
6 lations of the Senate on the Bank's assistance for exports  
7 that may be used in connection with the sale or lease of  
8 passenger aircraft and spare parts for such aircraft to the  
9 Islamic Republic of Iran by a non-U.S. manufacturer, and  
10 whether any such assistance for exports may be used in  
11 connection with a commercial passenger aircraft or spare  
12 parts comprising 10 percent or more U.S. content
