## A BILL

To amend section 310 of the Supplemental Appropriations Act, 2009 to extend the period of time during which claims for retroactive stop-loss special pay may be submitted.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TIME PERIOD FOR SUBMISSION OF CLAIMS**

4 **FOR RETROACTIVE STOP-LOSS SPECIAL PAY.**

5 (a) EXTENSION.—Section 310(b) of the Supple-  
6 mental Appropriations Act, 2009 (Public Law 111–32;

1 123 Stat. 1871) is amended by striking “1 year” both  
2 places it appears and inserting “2 years”.

3 (b) PLAN FOR IMPROVED DOD INFORMATION DIS-  
4 SEMINATION EFFORTS.—

5 (1) PLAN REQUIRED.—As part of the report re-  
6 quired by subsection (h) of section 310 of the Sup-  
7 plemental Appropriations Act, 2009 (Public Law  
8 111–32; 123 Stat. 1871), the Secretary of Defense  
9 shall include a plan describing Department of De-  
10 fense outreach and informational efforts to promote  
11 and increase awareness of the retroactive availability  
12 stop-loss special pay under such section. The plan  
13 shall include a timeline for full implementation of  
14 the plan.

15 (2) SPECIAL CONSIDERATIONS.—In developing  
16 the plan, the Secretary of Defense shall consider, at  
17 a minimum, the following:

18 (A) Previous Department of Defense out-  
19 reach and informational efforts and how these  
20 efforts will be expanded and improved to make  
21 eligible members of the Armed Forces and vet-  
22 erans aware of the availability of retroactive  
23 stop-loss payments.

24 (B) Department of Defense efforts to co-  
25 ordinate with the Department of Veterans Af-

1           fairs, veteran service organizations, and other  
2           pertinent veteran groups to increase and im-  
3           prove outreach and awareness of the availability  
4           of retroactive stop-loss payments.

5           (C) Contacting members of the Armed  
6           Forces who have transferred to the Individual  
7           Ready Reserve since September 11, 2001, as a  
8           way of increasing awareness of the availability  
9           of retroactive stop-loss payments.

10          (3) EXPLANATION.—In the report referred to in  
11          paragraph (1), the Secretary of Defense shall de-  
12          scribe how the Secretary addressed each of the spe-  
13          cial considerations specified in paragraph (2). If the  
14          decision is made not to fully implement one or more  
15          of the special considerations, the Secretary shall ex-  
16          plain why that decision was made.
