To authorize community development block grants for providing tools, equipment, and other resources.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Tools On Our Local
- 5 Streets to Rehabilitate Communities Act of 2018" or the
- 6 "TOOLS to Rehabilitate Communities Act of 2018".
