## A BILL

To amend title 18, United States Code, to strengthen enforcement of spousal court-ordered property distributions, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Jane’s Law”.

5 **SEC. 2. SPOUSAL OBLIGATIONS.**

6 (a) IN GENERAL.—Chapter 11A of title 18, United  
7 States Code, is amended by adding at the end the fol-  
8 lowing:

1 **“§ 228A. Failure to pay legal spousal court-ordered**  
 2 **property distribution**

3 “(a) OFFENSE.—Whoever knowingly, travels in inter-  
 4 state or foreign commerce, with the intent to evade compli-  
 5 ance with a court ordered property distribution as part  
 6 of a separation or divorce settlement involving more than  
 7 \$5,000, with respect to a spouse or former spouse, shall  
 8 be fined under this title or imprisoned for not more than  
 9 two years or both.

10 “(b) MANDATORY RESTITUTION.—Upon a conviction  
 11 under this section, the court shall order restitution under  
 12 section 3663A in an amount equal to the total unpaid  
 13 property distribution.

14 “(c) DEFINITION.—The term ‘court ordered property  
 15 distribution’ means any amount determined under a court  
 16 order pursuant to the law of a State or of an Indian tribe  
 17 to be due from a spouse or former spouse as an equitable  
 18 or other distribution to a spouse or former spouse of assets  
 19 in connection with a separation or divorce.”.

20 (b) CLERICAL AMENDMENTS.—

21 (1) TABLE OF SECTIONS.—The table of sections  
 22 at the beginning of chapter 11A of title 18, United  
 23 States Code, is amended by adding at the end the  
 24 following new item:

“228A. Failure to pay legal spousal obligations.”.

1           (2) TABLE OF CHAPTERS.—The item in the  
2           table of chapters for part I of title 18, United States  
3           Code, relating to chapter 11A is amended to read as  
4           follows:

**“11A. Child support and spousal obligations ..... 228”.**
