## A BILL

To amend the Food and Nutrition Act of 2008 to require that supplemental nutrition assistance program benefits be calculated with reference to the cost of the low-cost food plan as determined by the Secretary of Agriculture, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Food Security Im-  
5 provement Act of 2018”.

1 **SEC. 2. CALCULATION OF SUPPLEMENTAL NUTRITION AS-**  
2 **SISTANCE PROGRAM BENEFITS USING COST**  
3 **OF LOW-COST FOOD PLAN.**

4 The Food and Nutrition Act of 2008 (7 U.S.C. 2011  
5 et seq.) is amended—

6 (1) in section 3 (7 U.S.C. 2012) by inserting  
7 after subsection (l) the following:

8 “(l–A) ‘Low-cost food plan’ means the cost of the diet  
9 determined by the Secretary, as described in ‘The Low-  
10 Cost, Moderate-Cost, and Liberal Food Plans, 2007’, pub-  
11 lished by the Center for Nutrition Policy and Promotion  
12 (CNPP–20, November 2007) of the Department of Agri-  
13 culture. The cost of such diet shall be the basis for uni-  
14 form allotments for all households regardless of their ac-  
15 tual composition, except that the Secretary shall—

16 “(1) make household-size adjustments (based  
17 on the unrounded cost of such diet) taking into ac-  
18 count economies of scale;

19 “(2) make cost adjustments in the low-cost food  
20 plan for Hawaii and the urban and rural parts of  
21 Alaska to reflect the cost of food in Hawaii and  
22 urban and rural Alaska;

23 “(3) make cost adjustments in the separate  
24 low-cost food plans for Guam, and the Virgin Is-  
25 lands of the United States, to reflect the cost of food

1 in those States, but not to exceed the cost of food  
2 in the 50 States and the District of Columbia; and

3 “(4) on October 1, 2019, and each October 1  
4 thereafter, adjust the cost of the diet to reflect the  
5 cost of the diet in the preceding June, and round the  
6 result to the nearest lower dollar increment for each  
7 household size.”;

8 (2) in section 8(a) (7 U.S.C. 2017(a)) by strik-  
9 ing “thrifty food plan” each place it appears, and in-  
10 sserting “low-cost food plan”; and

11 (3) in section 19(a)(2)(A) (7 U.S.C.  
12 2028(a)(2)(A))—

13 (A) in clause (i) by striking “and” at the  
14 end;

15 (B) in clause (ii)—

16 (i) by striking “each fiscal year there-  
17 after” and inserting “each of the fiscal  
18 years 2004 through 2018”; and

19 (ii) by striking the period at the end  
20 and inserting a semicolon; and

21 (C) by adding at the end the following:

22 “(iii) for fiscal year 2019,  
23 \$2,191,000,000; and

24 “(iv) subject to the availability of ap-  
25 propriations under section 18(a), for fiscal

1 year 2018 and each fiscal year thereafter,  
2 the amount determined under clause (iii),  
3 as adjusted by the percentage by which the  
4 low-cost food plan has been adjusted under  
5 section 3(l-A)(4) between June 30, 2018,  
6 and June 30 of the immediately preceding  
7 fiscal year.”.
