Mr. MEADOWS introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To provide for recreational access for floating cabins on the Tennessee River System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. RECREATIONAL ACCESS OF FLOATING CABINS**
4 **ON WATERS UNDER THE JURISDICTION OF**
5 **THE TENNESSEE VALLEY AUTHORITY.**

6 (a) RECREATIONAL ACCESS PERMITTED.—The
7 Board of Directors of the Tennessee Valley Authority may
8 approve and allow the construction and use of a floating
9 cabin on waters under the jurisdiction of the Tennessee
10 Valley Authority if—

1 (1) the floating cabin is maintained by the
2 owner to reasonable health, safety, and environ-
3 mental standards, as required by the Board of Di-
4 rectors; and

5 (2) the Tennessee Valley Authority has author-
6 ized the use of recreational vessels on such waters.

7 (b) FEES.—The Board of Directors may levy fees on
8 the owner of a floating cabin on waters under the jurisdic-
9 tion of the Tennessee Valley Authority for purposes of en-
10 suring compliance with subsection (a), so long as such fees
11 are necessary and reasonable for such purposes.

12 (c) CONTINUED RECREATIONAL USE.—With respect
13 to a floating cabin located on waters under the jurisdiction
14 of the Tennessee Valley Authority on the date of enact-
15 ment of this section, the Board of Directors—

16 (1) may not require the removal of such float-
17 ing cabin—

18 (A) in the case of a floating cabin that was
19 granted a permit by the Tennessee Valley Au-
20 thority before the date of enactment of this sec-
21 tion, for a period of 15 years beginning on such
22 date; and

23 (B) in the case of a floating cabin not
24 granted a permit by the Tennessee Valley Au-
25 thority before the date of enactment of this sec-

1 tion, for a period of 5 years beginning on such
2 date; and

3 (2) shall approve and allow the use of the float-
4 ing cabin on waters under the jurisdiction of the
5 Tennessee Valley Authority at such time, and for
6 such duration, as the floating cabin meets the re-
7 quirements of subsection (a) and the owner of such
8 cabin has paid any fee levied pursuant to subsection
9 (b).

10 (d) DEFINITION OF FLOATING CABIN.—In this sec-
11 tion, the term “floating cabin” means every description
12 of watercraft or other floating structure primarily de-
13 signed and used for human habitation or occupation and
14 not primarily designed or used for navigation or transpor-
15 tation on water.
