A BILL

To amend the Adult Education and Family Literacy Act and the Workforce Innovation and Opportunity Act to strengthen adult education.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Adult Education Work-
5 force Opportunity and Reskilling for Knowledge and Suc-
6 cess Act” or the “Adult Education WORKS Act”.

1 **TITLE I—WORKFORCE**
2 **DEVELOPMENT ACTIVITIES**

3 **SEC. 101. WORKFORCE DEVELOPMENT ACTIVITIES.**

4 (a) AMENDMENT TO WIOA.—Except as otherwise ex-
5 pressly provided, whenever in this section an amendment
6 or repeal is expressed in terms of an amendment to, or
7 repeal of, a section or other provision, the reference shall
8 be considered to be made to a section or other provision
9 of the Workforce Innovation and Opportunity Act (29
10 U.S.C. 3101 et seq.).

11 (b) DEFINITIONS.—

12 (1) IN GENERAL.—Section 3 (29 U.S.C. 3102)
13 is amended—

14 (A) by striking paragraph (5);

15 (B) by redesignating paragraphs (6)
16 through (9) as paragraphs (5) through (8), re-
17 spectively;

18 (C) by inserting after paragraph (8), as re-
19 designated by subparagraph (B), the following:

20 “(9) COLLEGE AND CAREER NAVIGATOR.—The
21 term ‘college and career navigator’ means an indi-
22 vidual who—

23 “(A) has extensive knowledge of workforce
24 development programs and services, postsec-
25 ondary programs and services, Federal and

1 other student financial aid for postsecondary
2 education, and case management techniques;

3 “(B) supports persons who are accessing
4 services under this Act, by gathering work his-
5 tory and skills information, providing tailored
6 college and career guidance and labor market
7 information, helping jobseekers identify training
8 and educational options to best fit their needs,
9 including Federal student aid and other assist-
10 ance available to pay the costs of attendance at
11 an institution of higher education or for partici-
12 pation in training, facilitating access to serv-
13 ices, and facilitating co-enrollment of individ-
14 uals in programs carried out under title I and
15 title II;

16 “(C) provides or organizes provision of
17 services to promote job readiness, digital lit-
18 eracy skills, information literacy skills, and the
19 skills needed for success in postsecondary edu-
20 cation, facilitates the successful transition of in-
21 dividuals to postsecondary education, coordi-
22 nates activities with employers and with entities
23 and individuals involved in the one-stop delivery
24 system in the local area, and conducts commu-
25 nity outreach; and

1 “(D) as determined appropriate by the
2 one-stop operator or eligible provider of adult
3 education and literacy activities involved, is re-
4 sponsible for recruitment of students in adult
5 education and literacy activities and partici-
6 pants in workforce investment activities, provi-
7 sion of intensive case management, provision of
8 career exploration services, and data collection
9 associated with an activity specified in this sub-
10 paragraph.”;

11 (D) by redesignating paragraphs (12)
12 through (14), (15) through (21), (22) through
13 (26), and (27) through (71), as paragraphs
14 (13) through (15), (17) through (23), (25)
15 through (29), and (31) through (75), respec-
16 tively;

17 (E) by inserting after paragraph (11) the
18 following:

19 “(12) CONCURRENT ENROLLMENT.—The term
20 ‘concurrent enrollment’ has the meaning given the
21 term in section 203.”;

22 (F) by inserting after paragraph (15), as
23 redesignated by subparagraph (D), the fol-
24 lowing:

1 “(16) DIGITAL LITERACY SKILLS.—The term
2 ‘digital literacy skills’ has the meaning given the
3 term in section 203.”;

4 (G) by inserting after paragraph (23), as
5 redesignated by subparagraph (D), the fol-
6 lowing:

7 “(24) FOUNDATIONAL SKILL NEEDS.—The
8 term ‘foundational skill needs’, used with respect to
9 an individual, means—

10 “(A) in the case of an individual who is a
11 youth, an individual who has English reading,
12 writing, or computing skills at or below the 8th
13 grade level on a generally accepted standardized
14 test; or

15 “(B) in the case of an individual who is a
16 youth or adult, an individual who is unable to
17 compute or solve problems, or read, write, or
18 speak English, at a level necessary to function
19 on the job, in the individual’s family, or in soci-
20 ety.”; and

21 (H) by inserting after paragraph (29), as
22 redesignated by subparagraph (D), the fol-
23 lowing:

1 “(30) INFORMATION LITERACY SKILLS.—The
2 term ‘information literacy skills’ has the meaning
3 given the term in section 203.”.

4 (2) CONFORMING AMENDMENTS.—

5 (A) Section 121(h)(2)(C)(ii) (29 U.S.C.
6 3151(h)(2)(C)(ii)) is amended by striking “sec-
7 tion 3(13)(D)” and inserting “section
8 3(14)(D)”.

9 (B) Section 134(c)(3)(H)(i) (29 U.S.C.
10 3174(c)(3)(H)(i)) is amended by striking “sec-
11 tion 3(44)” and inserting “section 3(48)”.

12 (C) Section 170(b)(1)(D)(i) (29 U.S.C.
13 3225(b)(1)(D)(i)) is amended by striking “sec-
14 tion 3(15)(E)” and inserting “section
15 3(17)(E)”.

16 (D) Section 211(e)(3) (29 U.S.C.
17 3291(e)(3)) is amended by striking “section
18 3(45)” and inserting “section 3(49)”.

19 (c) STATE WORKFORCE DEVELOPMENT BOARDS.—

20 Section 101 (29 U.S.C. 3111) is amended—

21 (1) in subsection (b)(1)(C)(ii)(IV), by inserting
22 “, and representatives of organizations that provide
23 adult education” after “out-of-school youth”; and

24 (2) in subsection (d)—

1 (A) in paragraph (7)(A), by striking “(as
2 defined in section 202 of the Museum and Li-
3 brary Services Act (20 U.S.C. 9101); referred
4 to in this Act as ‘digital literacy skills’)”;

5 (B) in paragraph (11), by striking “and”
6 at the end;

7 (C) by redesignating paragraph (12) as
8 paragraph (13); and

9 (D) by inserting after paragraph (11) the
10 following:

11 “(12) in collaboration with providers of adult
12 education and literacy activities, the promotion of
13 the employment of college and career navigators by
14 the one-stop centers in the State; and”.

15 (d) PROGRAM SPECIFICS FOR STATE PLANS.—Sec-
16 tion 102(b)(2) (29 U.S.C. 3112(b)(2)) is amended—

17 (1) in subparagraph (D)(ii)—

18 (A) in subclause (II), by striking item (dd)
19 and inserting the following:

20 “(dd) integrated education
21 and training, including how costs
22 for such activities will be shared
23 among relevant core programs;”;

24 (B) in subclause (V), by adding “and” at
25 the end; and

1 (C) by adding at the end the following:

2 “(VI) how the eligible agency will
3 promote, through funding priority or
4 other means, professionalization of
5 adult education and literacy activities
6 through the adoption of staffing mod-
7 els that include requirements and sup-
8 port for teacher credentialing, stand-
9 ards, and support for ongoing in-serv-
10 ice professional development, and ca-
11 reer ladders for professional growth,
12 which may include more opportunities
13 for full-time teaching positions;” and

14 (2) in subparagraph (E)(iii)(II), by inserting
15 “providers of adult education and literacy activities,”
16 after “institutions of higher education,”.

17 (e) LOCAL BOARDS.—Section 107 (29 U.S.C. 3122)
18 is amended—

19 (1) in subsection (c)(1), by adding at the end
20 the following:

21 “(D) INFORMATION ON MEMBERSHIP.—
22 The chief elected officials appointing the local
23 board for a local area shall make publicly avail-
24 able information on the membership of the
25 board (including information identifying how

1 the membership composition requirements of
2 subsection (b) have been met), including by
3 posting that information on the website of each
4 unit of general local government included in the
5 local area.”; and

6 (2) in subsection (d)—

7 (A) in paragraph (5), by striking “sec-
8 ondary and postsecondary education” and in-
9 serting “secondary, postsecondary, and adult
10 education”;

11 (B) in paragraph (7)(C)—

12 (i) by inserting “, in consultation with
13 providers of public access to technology,”
14 after “identifying strategies”;

15 (ii) by inserting “, including deliveries
16 through public libraries,” after “traditional
17 service delivery”; and

18 (iii) by inserting “and information lit-
19 eracy skills” after “digital literacy skills”;
20 and

21 (C) by adding at the end the following:

22 “(14) COLLEGE AND CAREER NAVIGATORS.—

23 The local board, in collaboration with providers of
24 adult education and literacy activities in the local
25 area, shall promote the employment of college and

1 career navigators by the one-stop centers and eligible
2 providers (as defined in section 203) in the local
3 area.”.

4 (f) LOCAL PLANS.—Section 108 (29 U.S.C. 3123) is
5 amended—

6 (1) in subsection (b)(13), by inserting “, includ-
7 ing, in all local plans after the first such plan, a de-
8 scription of how the local board carried out such co-
9 ordination and completed such review during the
10 previous 4-year period” after “submitted under title
11 II”; and

12 (2) in subsection (d)(3), by inserting “, along
13 with a description of the actions the local board took
14 in response to such comments” after “disagreement
15 with the plan”.

16 (g) INDICATORS OF PERFORMANCE.—Section
17 116(b)(2)(A) (29 U.S.C. 3141(b)(2)(A)) is amended—

18 (1) in clause (i), by striking subclauses (IV)
19 and (V) and inserting the following:

20 “(IV) the percentages of program
21 participants who, during participation
22 in the program—

23 “(aa) obtain a recognized
24 postsecondary credential or a sec-

1 ondary school diploma or its rec-
2 ognized equivalent; and

3 “(bb) are in an education or
4 training program that leads to a
5 recognized postsecondary creden-
6 tial or employment and who are
7 achieving measurable skill gains
8 toward such a credential or em-
9 ployment;

10 “(V) the percentages of program
11 participants who, within 1 year after
12 exit from the program—

13 “(aa) obtain a secondary
14 school diploma or its recognized
15 equivalent;

16 “(bb) have obtained or re-
17 tained employment; and

18 “(cc) are in an education or
19 training program leading to a
20 recognized postsecondary creden-
21 tial; and”;

22 (2) by striking clause (iii) and inserting the fol-
23 lowing:

24 “(iii) INTERIM INDICATORS FOR
25 ADULT EDUCATION.—A State may develop

1 interim indicators for measuring the per-
2 centage of program participants on track
3 to meet the indicators described in sub-
4 clauses (IV) and (V) of clause (i) for adult
5 education and literacy activities authorized
6 under title II.”; and

7 (3) in clause (iv), by striking “clauses (i)(VI)”
8 and inserting “clause (i)(VI)”.

9 (h) COMMON PARTICIPANT INDIVIDUAL RECORD
10 LAYOUT.—Section 116 (29 U.S.C. 3141) is amended by
11 adding at the end the following:

12 “(j) COMMON PARTICIPANT INDIVIDUAL RECORD
13 LAYOUT.—The Secretary of Labor and the Secretary of
14 Education shall establish a common reporting system that
15 covers, and that accommodates, the core programs, relat-
16 ing to participant records and the performance account-
17 ability measures described in subsection (b).”.

18 (i) ONE-STOP DELIVERY SYSTEMS.—Section 121 (29
19 U.S.C. 3151) is amended—

20 (1) in subsection (d)(2)(B)—

21 (A) by redesignating clauses (ii) through
22 (vi) as clauses (iii) through (vii), respectively;
23 and

24 (B) by inserting after clause (i) the fol-
25 lowing:

1 “(ii) a public library;” and
2 (2) in subsection (e)—
3 (A) in paragraph (2)(B)—
4 (i) in clause (i), by striking “and” at
5 the end;
6 (ii) in clause (ii), by striking the semi-
7 colon and inserting “; and”; and
8 (iii) by adding at the end the fol-
9 lowing:
10 “(iii) through one or more public li-
11 braries in accordance with paragraph
12 (5);” and
13 (B) by adding at the end the following:
14 “(5) INFORMATION AND SERVICES PROVIDED
15 THROUGH PUBLIC LIBRARIES.—A local board may
16 use funds made available under subsection (h) to
17 make programs, activities, and services available
18 through a public library to the extent such library
19 demonstrates to the local board—
20 “(A) that the library provides or will pro-
21 vide career services or other workforce develop-
22 ment activities to address unmet need for such
23 services or activities, such as by providing ca-
24 reer services and other workforce development
25 activities to individuals at days or times, and lo-

1 cations, at which the services or activities are
2 not otherwise made available through the cor-
3 responding one-stop partners;

4 “(B) that the library will provide a phys-
5 ical location within the library, which may in-
6 clude a mobile library site, in which to serve in-
7 dividuals seeking services provided by a college
8 and career navigator; and

9 “(C) the library’s ability to leverage addi-
10 tional resources, such as staff, facilities, com-
11 puter access, or learning materials, in order to
12 extend the level of services otherwise provided
13 through the local one-stop delivery system, par-
14 ticularly to geographically distant communities,
15 communities for which physical one-stop centers
16 are not easily accessible through public trans-
17 portation, or communities in which there is in-
18 adequate access for the level of services need-
19 ed.”.

20 (j) DIGITAL LITERACY SKILLS; INFORMATION LIT-
21 ERACY SKILLS.—Section 134(c) (29 U.S.C. 3174(c)) is
22 amended—

23 (1) in paragraph (2)(A)—

1 (A) in clause (iii), by inserting “digital lit-
2 eracy, information literacy,” after “(including
3 literacy,”; and

4 (B) in clause (xii)(VI), by inserting “dig-
5 ital literacy skills, information literacy skills,”
6 after “learning skills,”; and

7 (2) in paragraph (3)(D)—

8 (A) by redesignating clauses (x) and (xi)
9 as clauses (xii) and (xiii), respectively; and

10 (B) by inserting after clause (ix) the fol-
11 lowing:

12 “(x) digital literacy skills training;

13 “(xi) information literacy skills train-
14 ing;”.

15 (k) LIBRARY-BASED AND COMMUNITY-BASED COL-
16 LEGE AND CAREER NAVIGATORS.—Subtitle D of title I
17 is amended by inserting after section 171 (29 U.S.C.
18 3226) the following:

19 **“SEC. 171A. LIBRARY-BASED AND COMMUNITY-BASED COL-**
20 **LEGE AND CAREER NAVIGATORS.**

21 “(a) PURPOSE.—The purpose of this section is to ex-
22 pand the capacity of State and local workforce develop-
23 ment systems by leveraging the facilities and staff of li-
24 braries and community-based organizations to provide ca-

1 reer navigation services to individuals through library-
2 based and community-based college and career navigators.

3 “(b) ELIGIBLE ENTITY.—In this section, the term
4 ‘eligible entity’ means a partnership between a State board
5 or local board and 1 or more of the following:

6 “(1) A community-based organization.

7 “(2) A library (as defined in section 213 of the
8 Library Services and Technology Act (20 U.S.C.
9 9122)) that offers workforce development activities
10 at no cost to individuals.

11 “(c) GRANTS AUTHORIZED.—From funds made
12 available under section 172(g), the Secretary is authorized
13 to make grants to eligible entities to carry out the purpose
14 of this section.

15 “(d) APPLICATION.—To be eligible to receive a grant
16 under this section, an eligible entity shall submit an appli-
17 cation to the Secretary at such time, in such manner, and
18 containing such information as the Secretary may require.

19 “(e) USES OF FUNDS.—

20 “(1) IN GENERAL.—An eligible entity that re-
21 ceives a grant under this section shall use funds
22 made available through the grant to establish a col-
23 lege and career navigator program within the li-
24 brary, community-based organization, or agency that
25 is a partner of such eligible entity.

1 “(2) ACTIVITIES OF PROGRAM.—A college and
2 career navigator program established under para-
3 graph (1) may hire, train, support, or retain 1 or
4 more college and career navigators to provide career
5 navigation services in coordination with a State or
6 local workforce development system.”.

7 (1) AUTHORIZATION OF APPROPRIATIONS.—Section
8 172 (20 U.S.C. 3227) is amended by adding at the end
9 the following:

10 “(g) LIBRARY-BASED AND COMMUNITY-BASED
11 NAVIGATORS.—There are authorized to be appropriated to
12 carry out section 171A, \$135,000,000 for fiscal year 2025
13 and each of the 4 succeeding fiscal years.”.

14 **TITLE II—ADULT EDUCATION** 15 **AND LITERACY**

16 **SEC. 201. PURPOSE.**

17 Section 202(1) of the Adult Education and Family
18 Literacy Act (29 U.S.C. 3271(1)) is amended—

19 (1) by inserting “(including digital literacy
20 skills and information literacy skills)” after “skills”;
21 and

22 (2) by striking “and economic self-sufficiency”
23 and inserting “, economic self-sufficiency, and full
24 participation in all aspects of adult life”.

1 **SEC. 202. DEFINITIONS.**

2 Section 203 of the Adult Education and Family Lit-
3 eracy Act (29 U.S.C. 3272) is amended—

4 (1) in paragraph (1)—

5 (A) by striking “postsecondary level” and
6 inserting “college placement level”;

7 (B) in subparagraph (B), by striking
8 “and” after the semicolon;

9 (C) by redesignating subparagraph (C) as
10 subparagraph (E); and

11 (D) by inserting after subparagraph (B)
12 the following:

13 “(C) develop and use digital literacy skills;

14 “(D) develop and use information literacy
15 skills; and”;

16 (2) by redesignating paragraphs (3) through
17 (9) and (10) through (17) as paragraphs (6)
18 through (12) and (14) through (21), respectively;

19 (3) by inserting after paragraph (2) the fol-
20 lowing:

21 “(3) COLLEGE PLACEMENT LEVEL.—The term
22 ‘college placement level’ means the level required for
23 placement in college-level course work, rather than
24 placement in developmental education, as dem-
25 onstrated by achievement of a designated score on a
26 placement test or other college-identified measure.

1 “(4) CONCURRENT ENROLLMENT.—The term
2 ‘concurrent enrollment’ means intentional, simulta-
3 neous enrollment in more than 1 one-stop partner
4 program, as a strategy for leveraging resources and
5 eliminating duplication of services while achieving
6 the best possible outcomes.

7 “(5) DIGITAL LITERACY SKILLS.—The term
8 ‘digital literacy skills’ means the skills associated
9 with—

10 “(A) using technology to enable users to
11 find, evaluate, organize, create, and commu-
12 nicate information; and

13 “(B) developing digital citizenship and the
14 responsible use of technology.”;

15 (4) in paragraph (7), as redesignated by para-
16 graph (2), in subparagraph (C)(i), by striking “is
17 basic skills deficient” and inserting “has
18 foundational skills needs”;

19 (5) in paragraph (9), as redesignated by para-
20 graph (2), in subparagraph (B)(i)—

21 (A) in subclause (I), by striking “and”
22 after the semicolon;

23 (B) in subclause (II), by striking “or” and
24 inserting “and”; and

25 (C) by adding at the end the following:

1 “(III) development of digital lit-
2 eracy skills and information literacy
3 skills; or”;

4 (6) in paragraph (12), as redesignated by para-
5 graph (2), in the matter preceding subparagraph
6 (A), by inserting “and educational” after “in the
7 economic”;

8 (7) by inserting after paragraph (12), as redesi-
9 gnated by paragraph (2), the following:

10 “(13) INFORMATION LITERACY SKILLS.—The
11 term ‘information literacy skills’ means the set of
12 skills needed to find, retrieve, understand, evaluate,
13 analyze, discern the reliability and accuracy of, and
14 effectively use information (which encompasses spo-
15 ken and broadcast words and videos, printed mate-
16 rials, and digital content, data, and images).”;

17 (8) in paragraph (15), as redesignated by para-
18 graph (2), by inserting “(and may be provided con-
19 currently with other activities and services, such as
20 adult basic education)” after “workforce training”;

21 (9) in paragraph (17), as redesignated by para-
22 graph (2), by striking “and solve problems, at levels
23 of proficiency necessary to function on the job, in
24 the family of the individual, and in society” and in-
25 serting “solve problems, and use digital literacy

1 skills and information literacy skills at levels of pro-
2 ficiency necessary to function effectively as an em-
3 ployee, a parent or family member, and a member
4 of society”; and

5 (10) in paragraph (21), as redesignated by
6 paragraph (2)—

7 (A) by inserting “information literacy
8 skills,” after “digital literacy skills,”; and

9 (B) by striking “and completion of”.

10 **SEC. 203. AUTHORIZATION OF APPROPRIATIONS.**

11 Section 206 of the Adult Education and Family Lit-
12 eracy Act (29 U.S.C. 3275) is amended by striking “this
13 title” and all that follows through the period at the end
14 and inserting “this title \$810,000,000 for fiscal year
15 2025, \$945,000,000 for fiscal year 2026, \$1,080,000,000
16 for fiscal year 2027, \$1,215,000,000 for fiscal year 2028,
17 and \$1,350,000,000 for fiscal year 2029.”.

18 **SEC. 204. RESERVATION OF FUNDS.**

19 Section 211 of the Adult Education and Family Lit-
20 eracy Act (29 U.S.C. 3291) is amended in subsection
21 (a)(1), by striking “\$15,000,000” and inserting
22 “\$25,000,000”.

23 **SEC. 205. PERFORMANCE AND ACCOUNTABILITY SYSTEM.**

24 Section 212 of the Adult Education and Family Lit-
25 eracy Act (29 U.S.C. 3292) is amended to read as follows:

1 **“SEC. 212. PERFORMANCE AND ACCOUNTABILITY SYSTEM.**

2 “(a) IN GENERAL.—

3 “(1) IN GENERAL.—Except as provided in sub-
4 section (b), programs and activities authorized under
5 this title are subject to all of the performance ac-
6 countability provisions described in section 116.

7 “(2) ADDITIONAL MEASURABLE SKILL GAINS.—

8 With respect to the application to programs and ac-
9 tivities authorized under this title of the indicator of
10 measurable skill gains under section
11 116(b)(2)(A)(i)(IV), such measurable skill gains
12 may include those relating to the purpose described
13 in section 202.

14 “(b) PILOT FOR INNOVATIVE PERFORMANCE AC-
15 COUNTABILITY SYSTEMS.—

16 “(1) IN GENERAL.—The Secretary shall ap-
17 prove an application from an eligible agency to pilot,
18 for a subset of eligible providers within its State and
19 as an alternative to the performance accountability
20 system described in section 116, an innovative per-
21 formance accountability system that uses alternative
22 indicators of performance that have the potential to
23 more accurately reflect the objectives and adult edu-
24 cation and literacy activities of the eligible providers’
25 programs if the Secretary determines that an appli-

1 cation from such an eligible agency meets the re-
2 quirements of this subsection.

3 “(2) PILOT PERIOD.—An eligible agency apply-
4 ing to pilot an innovative performance accountability
5 system under this subsection shall propose in its ap-
6 plication the period of time that the agency desires
7 to implement such system, except that the period
8 shall not exceed 5 years.

9 “(3) EXTENSION OF A PILOT PERIOD.—The
10 Secretary shall approve an eligible agency’s request
11 to extend the period of a pilot under this subsection
12 if the Secretary determines that the innovative per-
13 formance system is meeting the objectives of this
14 subsection.

15 “(4) APPLICATION.—

16 “(A) IN GENERAL.—An eligible agency de-
17 siring to undertake a pilot under this subsection
18 shall submit an application at such time and in
19 such manner as the Secretary may require.

20 “(B) CONTENTS.—An application de-
21 scribed in subparagraph (A) shall include—

22 “(i) a description of how the eligible
23 agency engaged in an outreach process
24 with eligible providers within its State to—

1 “(I) inform the eligible providers
2 of the opportunity to implement a
3 pilot under this subsection; and

4 “(II) engage with the eligible
5 providers in the development of alter-
6 native indicators of performance;

7 “(ii) an explanation of whether and
8 how the eligible agency established any
9 standards or criteria for the alternative
10 measures of performance that participating
11 eligible providers could elect to use;

12 “(iii) a listing of the eligible providers
13 that will participate in the proposed pilot
14 and a description of the indicators of per-
15 formance that each such provider will
16 make use of through the pilot;

17 “(iv) a description of why the eligible
18 agency and the participating eligible pro-
19 viders believe the proposed indicators of
20 performance would more accurately meas-
21 ure the attainment of the objectives of

23 eracy activities than would the indicators
24 of performance described in section
25 116(b)(2);

1 “(v) an explanation of how the pro-
2 posed indicators of performance will be
3 valid and reliable measures of education
4 and employment consistent with purposes
5 of this title;

6 “(vi) a description of how the eligible
7 agency will collect, report to the Secretary,
8 and make publicly available the proposed
9 indicators of performance from each par-
10 ticipating eligible provider on a timely
11 basis; and

12 “(vii) an assurance that the eligible
13 agency will, at the end of the pilot period,
14 report to the Secretary on the outcomes of
15 the pilot, including on whether the eligible
16 agency met the objectives of the pilot.

17 “(C) SECRETARIAL REVIEW AND AP-
18 PROVAL.—The Secretary shall determine wheth-
19 er to approve an application under this sub-
20 section by not later than 90 days of receiving
21 the application.

22 “(D) DISAPPROVAL.—The Secretary shall
23 not disapprove an application under this sub-
24 section without giving the applicant the oppor-
25 tunity to revise and resubmit the application.

1 “(5) ADDITIONAL SECRETARIAL RESPONSIBIL-
2 ITIES.—The Secretary shall—

3 “(A) through the Director of the Institute
4 of Education Sciences, carry out national eval-
5 uations of the implementation and outcomes of
6 the pilots authorized under this subsection, with
7 the first such evaluation to be completed not
8 later than 5 years after the Secretary approves
9 the first application from an eligible entity;

10 “(B) in consultation with the Director of
11 the Institute of Education Sciences, identify
12 best practices in the development and imple-
13 mentation of innovative performance account-
14 ability systems under this subsection;

15 “(C) disseminate information on those
16 practices, including by making the information
17 available on the website of the Department of
18 Education; and

19 “(D) provide a report to the Committee on
20 Health, Education, Labor, and Pensions of the
21 Senate and the Committee on Education and
22 the Workforce of the House of Representatives
23 on the results of the pilot program, including a
24 comparison of the outcomes as measured by the
25 innovative performance accountability systems

1 implemented under this subsection and the per-
2 formance measures described in section 116.”.
