A BILL

To provide for expedited approval of exportation of natural gas to World Trade Organization countries, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Domestic Prosperity
5 and Global Freedom Act”.

6 **SEC. 2. AMENDMENTS.**

7 Section 3(e) of the Natural Gas Act (15 U.S.C.
8 717b(e)) is amended—

9 (1) by inserting “(1)” before “For purposes”;

10 (2) by striking “a nation with which there is in
11 effect a free trade agreement requiring national
12 treatment for trade in natural gas” and inserting “a
13 World Trade Organization member nation”; and

14 (3) by adding at the end the following:

15 “(2) For purposes of this subsection, the term ‘World
16 Trade Organization member nation’ means a country de-
17 scribed in section 2(10) of the Uruguay Round Agree-
18 ments Act (19 U.S.C. 3501(10)).”.

19 **SEC. 3. PENDING APPLICATIONS.**

20 Any application for authorization to export natural
21 gas under section 3 of the Natural Gas Act (15 U.S.C.
22 717b) for which a notice has been published in the Federal
23 Register before March 6, 2014, shall be granted without
24 modification or delay.

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Domestic Prosperity and*
3 *Global Freedom Act”.*

4 **SEC. 2. ACTION ON APPLICATIONS.**

5 (a) *DECISION DEADLINE.*—*The Department of Energy*
6 *shall issue a decision on any application for authorization*
7 *to export natural gas under section 3 of the Natural Gas*
8 *Act (15 U.S.C. 717b) not later than 90 days after the later*
9 *of—*

10 (1) *the end of the comment period for such deci-*
11 *sion as set forth in the applicable notice published in*
12 *the Federal Register; or*

13 (2) *the date of enactment of this Act.*

14 (b) *JUDICIAL ACTION.*—(1) *The United States Court*
15 *of Appeals for the circuit in which the export facility will*
16 *be located pursuant to an application described in sub-*
17 *section (a) shall have original and exclusive jurisdiction*
18 *over any civil action for the review of—*

19 (A) *an order issued by the Department of En-*
20 *ergy with respect to such application; or*

21 (B) *the Department of Energy’s failure to issue*
22 *a decision on such application.*

23 (2) *If the Court in a civil action described in para-*
24 *graph (1) finds that the Department of Energy has failed*
25 *to issue a decision on the application as required under*
26 *subsection (a), the Court shall order the Department of En-*

1 *ergy to issue such decision not later than 30 days after the*
2 *Court's order.*

3 *(3) The Court shall set any civil action brought under*
4 *this subsection for expedited consideration and shall set the*
5 *matter on the docket as soon as practical after the filing*
6 *date of the initial pleading.*

7 ***SEC. 3. PUBLIC DISCLOSURE OF EXPORT DESTINATIONS.***

8 *Section 3 of the Natural Gas Act (15 U.S.C. 717b) is*
9 *amended by adding at the end the following:*

10 *“(g) PUBLIC DISCLOSURE OF LNG EXPORT DESTINA-*
11 *TIONS.—As a condition for approval of any authorization*
12 *to export LNG, the Secretary of Energy shall require the*
13 *applicant to publicly disclose the specific destination or des-*
14 *tinations of any such authorized LNG exports.”.*
