A BILL

To extend supplemental agricultural disaster assistance programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Agricultural Disaster
5 Assistance Act of 2012”.

1 **SEC. 2. SUPPLEMENTAL AGRICULTURAL DISASTER ASSIST-**
2 **ANCE.**

3 (a) FEDERAL CROP INSURANCE ACT.—Section 531
4 of the Federal Crop Insurance Act (7 U.S.C. 1531) is
5 amended—

6 (1) in subsection (b)(4)—

7 (A) in subparagraph (A)(i)(II), by insert-
8 ing “the first 5 months of” after “received for”;
9 and

10 (B) in subparagraph (C), by inserting “the
11 first 5 months of” after “during the”; and

12 (2) in subsection (i), by striking “2011” and in-
13 sserting “2012”.

14 (b) TRADE ACT OF 1974.—

15 (1) IN GENERAL.—Section 901 of the Trade
16 Act of 1974 (19 U.S.C. 2497) is amended—

17 (A) in subsection (b)(4)—

18 (i) in subparagraph (A)(i)(II), by in-
19 sserting “the first 5 months of” after “re-
20 ceived for”; and

21 (ii) in subparagraph (C), by inserting
22 “the first 5 months of” after “during the”;
23 and

24 (B) in subsection (i), by striking “2011”
25 and inserting “2012”.

1 (2) AGRICULTURAL DISASTER RELIEF TRUST
2 FUND.—Section 902 of the Trade Act of 1974 (19
3 U.S.C. 2497a) is amended—

4 (A) in subsection (b)(1), by striking
5 “2011” and inserting “2012”; and

6 (B) in subsection (d), by striking “the
7 Food, Conservation, and Energy Act of 2008”
8 and inserting “Agricultural Disaster Assistance
9 Act of 2012”.

10 (c) APPLICATION.—The amendments made by this
11 section apply only to losses that are incurred as the result
12 of a disaster, adverse weather, or other environmental con-
13 dition that occurs during the 2012 crop year.
