## A BILL

To provide for the establishment of the Task Force on Environmental Health Risks and Safety Risks to Children.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Children’s Health Task  
5 Force Act of 2012”.

6 **SEC. 2. TASK FORCE ON ENVIRONMENTAL HEALTH RISKS**  
7 **AND SAFETY RISKS TO CHILDREN.**

8 (a) ESTABLISHMENT.—The Secretary of Health and  
9 Human Services and the Administrator of the Environ-  
10 mental Protection Agency, acting jointly, shall establish

1 and maintain a permanent task force, to be known as the  
2 Task Force on Environmental Health Risks and Safety  
3 Risks to Children (in this Act referred to as the “Task  
4 Force”).

5 (b) MEMBERSHIP.—The Task Force shall be com-  
6 posed of the following officials (or their designees):

7 (1) The Secretary of Health and Human Serv-  
8 ices, who shall serve as a Co-Chair of the Task  
9 Force.

10 (2) The Administrator of the Environmental  
11 Protection Agency, who shall serve as a Co-Chair of  
12 the Task Force.

13 (3) The Secretary of Education.

14 (4) The Secretary of Labor.

15 (5) The Attorney General of the United States.

16 (6) The Secretary of Energy.

17 (7) The Secretary of Housing and Urban Devel-  
18 opment.

19 (8) The Secretary of Agriculture.

20 (9) The Secretary of Transportation.

21 (10) The Secretary of Defense.

22 (11) The Secretary of the Interior.

23 (12) The Director of the Office of Management  
24 and Budget.

1           (13) The Chair of the Council on Environ-  
2           mental Quality.

3           (14) The Chair of the Consumer Product Safe-  
4           ty Commission.

5           (15) Such other officials of Federal depart-  
6           ments and agencies as the Secretary of Health and  
7           Human Services and the Administrator of the Envi-  
8           ronmental Protection Agency, acting jointly, may  
9           designate or invite (as appropriate) to serve on the  
10          Task Force.

11          (c) STAKEHOLDERS.—The Secretary of Health and  
12          Human Services and the Administrator of the Environ-  
13          mental Protection Agency, acting jointly, shall, as appro-  
14          priate, invite representatives of stakeholders to attend  
15          meetings of the Task Force, appear before the Task  
16          Force, and file statements with the Task Force, subject  
17          to such requirements as the Secretary and Administrator  
18          may determine.

19          (d) FUNCTIONS.—The Task Force shall recommend  
20          to the President and the Congress Federal strategies for  
21          addressing environmental health risks and safety risks to  
22          children in the United States, within projected budgetary  
23          limits, including the following:

24                  (1) Adoption of action plans, including  
25                  multiyear and annual priorities, to address the prin-

1        ciproal environmental health risks and safety risks to  
2        children.

3            (2) Initiatives that the Federal Government has  
4        undertaken or will undertake in addressing the prin-  
5        cipal environmental health risks and safety risks to  
6        children.

7            (3) Recommendations on how to improve cross-  
8        agency implementation of actions, including cross-  
9        agency budgeting, to address environmental health  
10       risks and safety risks to children.

11           (4) Recommendations for a coordinated re-  
12       search agenda for the Federal Government to ad-  
13       dress environmental health risks and safety risks to  
14       children.

15           (5) Recommendations for appropriate partner-  
16       ships among Federal, State, local, and tribal govern-  
17       ments and the private, academic, and nonprofit sec-  
18       tors.

19           (6) Proposed ways to enhance public outreach  
20       and communication to assist families in evaluating  
21       environmental health risks and safety risks to chil-  
22       dren and in making informed consumer choices.

23           (7) Proposed ways to strengthen the data sys-  
24       tem in order to identify and track development of  
25       rulemakings and other actions to ensure they comply

1 with current policy on evaluating environmental  
2 health risks and safety risks to children.

3 (e) REPORTS.—

4 (1) BIENNIAL REPORTS.—Not later than July  
5 31, 2013, and biennially thereafter, the Task Force  
6 shall submit to the President and the Congress,  
7 make publicly available, and disseminate widely a re-  
8 port including—

9 (A) the strategies developed and updated  
10 under subsection (d);

11 (B) in the case of reports subsequent to  
12 the first report, a description of the accomplish-  
13 ments of the Task Force since the preceding re-  
14 port;

15 (C) current national priorities for address-  
16 ing environmental health risks and safety risks  
17 to children in the United States and any related  
18 emerging issues;

19 (D) updates on Federal research findings  
20 and research needs regarding environmental  
21 risks and safety risks to children;

22 (E) information submitted to the Task  
23 Force by Federal departments and agencies for  
24 inclusion in the report;

1 (F) appropriate recommendations by the  
2 Children’s Health Protection Advisory Com-  
3 mittee; and

4 (G) information submitted by stakeholders  
5 for inclusion in the report.

6 (2) ADDITIONAL REPORTING.—In addition to  
7 the biennial reports under paragraph (1), the Task  
8 Force—

9 (A) may, as appropriate, submit to the  
10 President and the Congress such additional re-  
11 ports and updates as necessary;

12 (B) shall make any such reports and up-  
13 dates publicly available; and

14 (C) shall disseminate widely any such re-  
15 ports and updates.

16 (f) MEETINGS.—

17 (1) IN GENERAL.—The Task Force shall meet  
18 at least annually.

19 (2) NOTICE.—The Task Force shall—

20 (A) publish in the Federal Register timely  
21 notice of each upcoming meeting of the Task  
22 Force; and

23 (B) provide for other types of public notice  
24 to ensure that all interested persons receive

1           timely notice of each upcoming meeting of the  
2           Task Force.

3           (3) MINUTES.—

4                   (A) IN GENERAL.—The Task Force shall  
5           record and maintain detailed minutes of each  
6           meeting of the Task Force, including—

7                           (i) the meeting agenda;

8                           (ii) a record of the persons present;

9                           (iii) a complete and accurate descrip-  
10          tion of matters discussed at the meeting  
11          and conclusions reached; and

12                          (iv) copies of all reports received,  
13          issued, or approved by the Task Force in  
14          connection with the meeting.

15                   (B) PUBLIC AVAILABILITY; COPYING.—The  
16          Task Force shall make such minutes available  
17          for public inspection and copying.

18                   (C) ACCURACY.—The Co-Chairs of the  
19          Task Force shall certify the accuracy of all such  
20          minutes.

21           (g) TERMINATION OF EXISTING TASK FORCE.—The  
22          Task Force on Environmental Health Risks and Safety  
23          Risks to Children established by Executive Order 13045  
24          (April 21, 1997) is hereby terminated.

1       (h) AUTHORIZATION OF APPROPRIATIONS.—To carry  
2 out this Act, there are authorized to be appropriated such  
3 sums as may be necessary for fiscal year 2013 and each  
4 subsequent fiscal year.
