## A BILL

To prohibit the Federal Government from imposing a vaccine mandate on individuals traveling on public or private transportation for hire within the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Saving Americans  
5 From Executive Reach in Travel Act” or the “SAFER  
6 Travel Act”.

1 **SEC. 2. PROHIBITION ON IMPOSITION OF FEDERAL VAC-**  
2 **CINATION REQUIREMENT FOR TRAVEL.**

3 Notwithstanding any other provision of law, an Exec-  
4 utive agency (as defined in section 105 of title 5, United  
5 States Code) may not issue, implement, or enforce any  
6 regulation, requirement, guidance, or other directive that  
7 requires an individual to be vaccinated against COVID-  
8 19 as a condition to travel within the United States on  
9 any commercial public or private transportation subject to  
10 regulation by the Federal Government, including air, rail,  
11 commercial motor vehicle, vessel, or other public or private  
12 form of transportation.

13 **SEC. 3. PROHIBITION ON PUBLIC AND PRIVATE VACCINA-**  
14 **TION REQUIREMENT FOR TRAVEL.**

15 Notwithstanding any other provision of law, no entity  
16 engaged in the operation of any public or private transpor-  
17 tation for hire that is subject to regulation by the Federal  
18 Government may require an individual to be vaccinated  
19 against COVID-19 as a term or condition of travel.

20 **SEC. 4. PROHIBITION ON PERIOD OF MANDATORY QUAR-**  
21 **ANTINE.**

22 Notwithstanding any other provision of law, an Exec-  
23 utive agency (as defined in section 105 of title 5, United  
24 States Code) may not issue, implement, or enforce any  
25 regulation, requirement, guidance, or other directive that  
26 requires a citizen of the United States or lawful perma-

1 nent resident of the United States to enter into a period  
2 of quarantine related to COVID–19 after having traveled  
3 on any commercial public or private transportation subject  
4 to regulation by the Federal Government, including air,  
5 rail, commercial motor vehicle, vessel, or other such public  
6 or private transportation.
