A BILL

To amend the Controlled Substances Act to place certain
synthetic drugs in Schedule I.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Synthetic Cathinones
5 Control Act of 2012”.

1 **SEC. 2. ADDITION OF SYNTHETIC DRUGS TO SCHEDULE I**
2 **OF THE CONTROLLED SUBSTANCES ACT.**

3 Schedule I of section 202(c) of the Controlled Sub-
4 stances Act (21 U.S.C. 812(c)) is amended in subsection
5 (c) by adding at the end the following:

6 “(29) 3,4-methylenedioxyethcathinone
7 (methydone).

8 “(30) Naphthylpyrovalerone (naphyrone).

9 “(31) 4-fluoromethcathinone (flephedrone).

10 “(32) 4-methoxymethcathinone (methedrone;

12 “(33) Ethcathinone (N-ethylcathinone).

13 “(34) 3,4-methylenedioxyethcathinone
14 (ethylone).

15 “(35) Beta-keto-N-methyl-3,4-
16 benzodioxolybutanamine (butylone).

17 “(36) N,N-dimethylcathinone
18 (metamfepramone).

19 “(37) Alpha-pyrrolidinopropiophenone (alpha-
20 PPP).

21 “(38) 4-methoxy-alpha-pyrrolidinopropiophenone
22 (MOPPP).

23 “(39) 3,4-
24 methylenedioxyalphapyrrolidinopropiophenone
25 (MDPPP).

1 “(40) Alpha-pyrrolidinovalerophenone (alpha-
