## A BILL

To require that States and units of local government that receive funds under subpart I of part E of title I of the Omnibus Crime Control and Safe Streets Act of 1968 (42 U.S.C. 3750 et seq.) report information pertaining to hate crimes to the Attorney General for inclusion in the Uniform Crime Reports and National Incident-Based Reporting System, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1     **SECTION 1. SHORT TITLE.**

2         This Act may be cited as the “National Observations  
3     of Hate, Assaults, and Threats to Equality Act of 2016”  
4     or the “NO HATE Act of 2016”.

5     **SEC. 2. REPORTING OF HATE CRIMES.**

6         (a) IN GENERAL.—A State or unit of local govern-  
7     ment that receives funds under subpart I of part E of title  
8     I of the Omnibus Crime Control and Safe Streets Act of  
9     1968 (42 U.S.C. 3750 et seq.) shall provide to the Attor-  
10   ney General information pertaining to hate crimes com-  
11   mitted in that jurisdiction for the previous fiscal year. In  
12   the case of a State or unit of local government that fails  
13   substantially to provide the information required under  
14   this subsection, the Attorney General shall withhold the  
15   amount that would otherwise be awarded to that State or  
16   unit of local government under such grant program in the  
17   following fiscal year.

18         (b) INCLUSION OF INFORMATION IN CRIME RE-  
19     PORTS.—The Director of the Federal Bureau of Investiga-  
20     tion shall include the information received under sub-  
21     section (a) in the Uniform Crime Reports and the Na-  
22     tional Incident-Based Reporting System.

23         (c) DEFINITIONS.—For purposes of this section:

24                 (1) The term “Uniform Crime Reports” means  
25     the reports authorized under section 534 of title 28,  
26     United States Code, and administered by the Fed-

1       eral Bureau of Investigation which compiles nation-  
2       wide criminal statistics for use in law enforcement  
3       administration, operation, and management and to  
4       assess the nature and type of crime in the United  
5       States.

6                 (2) The term “hate crime” means a criminal of-  
7       fense against a person or property motivated in  
8       whole or in part by an offender’s bias against a race,  
9       religion, disability, sexual orientation, ethnicity, gen-  
10      der, or gender identity.
