**AN ACT**

Making further continuing appropriations for fiscal year  
2024, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Further Continuing  
5 Appropriations and Other Extensions Act, 2024”.

**1 SEC. 3. REFERENCES.**

2 Except as expressly provided otherwise, any reference  
3 to “this Act” contained in any division of this Act shall  
4 be treated as referring only to the provisions of that divi-  
5 sion.

**6 DIVISION A—FURTHER CONTINUING**  
**7 APPROPRIATIONS ACT, 2024**

8 SEC. 101. Division A of the Continuing Appropria-  
9 tions Act, 2024 and Other Extensions Act (Public Law  
10 118–15) is amended—

11 (1) by striking the date specified in section  
12 106(3) and inserting “February 2, 2024, except as  
13 provided in paragraph (4)”;

14 (2) by inserting after paragraph (3) of section  
15 106 the following:

16 “(4) In the case of appropriations and funds  
17 made available and authority granted pursuant to  
18 sections 101(1), 101(4), 101(10), 101(12), 134, and  
19 137, January 19, 2024.”;

20 (3) in section 101(1) by inserting after “except  
21 section 729,” the following: “and except that the  
22 language under the heading ‘Rural Utilities Serv-

1 ice—Rural Water and Waste Disposal Program Ac-  
2 count’ in title III shall be applied by inserting ‘direct  
3 loans and,’ before ‘loan guarantees’ at the beginning  
4 of the first sentence of the second paragraph,”;

5 (4) in section 101(10), by inserting before the  
6 period “, except section 123 as well as the provisions  
7 carrying the same restriction in prior Acts”;

8 (5) in section 123, by striking “17 days” and  
9 inserting “94 days” and by striking “17-day” and  
10 inserting “94-day”;

11 (6) in section 124, by striking “\$621,270,000”  
12 and inserting “\$663,070,000”;

13 (7) in section 125, by striking “During the pe-  
14 riod covered by this Act” and inserting “Through  
15 the date specified in section 106(3) of this Act”; and

16 (8) by adding after section 137 the following  
17 new sections:

18 “SEC. 138. Section 2(f)(2) of the Undetectable Fire-  
19 arms Act of 1988 (18 U.S.C. 922 note) shall be applied  
20 through the date specified in section 106(3) of this Act  
21 by substituting ‘36’ for ‘35’.

22 “SEC. 139. Through the date specified in section  
23 106(3) of this Act, amounts appropriated in section 124  
24 of the Continuing Appropriations Act, 2023 (division A  
25 of Public Law 117–180) may be charged for any proper

1 expense pursuant to section 1553(b)(1) of title 31, United  
2 States Code, notwithstanding the limitation in section  
3 1553(b)(2) of such title.

4 “SEC. 140. Notwithstanding sections 102 and 104,  
5 amounts made available by section 101 to the Department  
6 of Defense for ‘Procurement—Shipbuilding and Conver-  
7 sion, Navy’ may be apportioned up to the rate for oper-  
8 ations necessary for ‘Columbia Class Submarine (AP)’ in  
9 an amount not to exceed \$3,338,413,000.

10 “SEC. 141. (a) Notwithstanding section 101, section  
11 747 of title VII of division E of Public Law 117–328 shall  
12 be applied through the date specified in section 106(3) of  
13 this Act by—

14 “(1) substituting ‘2025’ for ‘2024’;

15 “(2) substituting ‘2024’ for ‘2023’ each place it ap-  
16 pears;

17 “(3) substituting ‘2023’ for ‘2022’ each place it ap-  
18 pears; and

19 “(4) substituting ‘section 747 of division E of Public  
20 Law 117–328, as in effect on September 30, 2023’ for  
21 ‘section 747 of division E of Public Law 117–103’ each  
22 place it appears.

23 “(b) Subsection (a) shall not take effect until the first  
24 day of the first applicable pay period beginning on or after  
25 January 1, 2024.

1       “SEC. 142. Section 302 of title III of Public Law  
2 108–494 shall be applied by substituting the date specified  
3 in section 106(3) of this Act for ‘December 31, 2023’ each  
4 place it appears.

5       “SEC. 143. Amounts made available by section 101  
6 to the Department of Homeland Security under the head-  
7 ing ‘United States Secret Service—Operations and Sup-  
8 port’ may be apportioned up to the rate for operations  
9 necessary to carry out activities related to National Spe-  
10 cial Security Events and the 2024 Presidential Campaign.

11       “SEC. 144. Section 1901(e) of the Homeland Secu-  
12 rity Act of 2002 (6 U.S.C. 591(e)) shall be applied by  
13 substituting the date that is 1 day after the date specified  
14 in section 106(3) of this Act for ‘the date that is 5 years  
15 after the date of the enactment of the Countering Weap-  
16 ons of Mass Destruction Act of 2018’.

17       “SEC. 145. (a) Amounts made available by section  
18 101 for ‘Department of Education—Student Aid Adminis-  
19 tration’ may be apportioned up to the rate for operations  
20 necessary to ensure the continuation of student loan serv-  
21 icing activities, including supporting borrowers reentering  
22 repayment.

23       “(b) The limitation in section 302 of division H of  
24 Public Law 117–328 regarding transfers increasing any  
25 appropriation shall be applied to transfers to appropria-

1 tions under the heading ‘Department of Education—Stu-  
2 dent Aid Administration’ through the date specified in sec-  
3 tion 106(3) of this Act by substituting ‘10 percent’ for  
4 ‘3 percent’ for the purposes of the continuation of basic  
5 operations, including student loan servicing, business  
6 process operations, digital customer care, common origina-  
7 tion and disbursement, cybersecurity activities, and infor-  
8 mation technology systems.

9       “SEC. 146. Notwithstanding any other provision of  
10 this Act, there is hereby appropriated for fiscal year 2024,  
11 out of any money in the Treasury not otherwise appro-  
12 priated, for payment to Katherine Anne Feinstein, bene-  
13 ficiary of Dianne Feinstein, late a Senator from the State  
14 of California, \$174,000.

15       “‘This division may be cited as the ‘Continuing Ap-  
16 propriations Act, 2024’.”.

17       This division may be cited as the “Further Con-  
18 tinuing Appropriations Act, 2024”.

4 **SEC. 101. EXTENSION OF CERTAIN PROVISIONS OF THE**  
5 **COMPACTS OF FREE ASSOCIATION WITH THE**  
6 **FEDERATED STATES OF MICRONESIA AND**  
7 **THE REPUBLIC OF THE MARSHALL ISLANDS.**

8 Section 2101 of the Continuing Appropriations Act,  
9 2024 and Other Extensions Act (Public Law 118–15; 137  
10 Stat. 81) is amended—

11 (1) in the section heading, by striking “**COM-**  
12 **PACT OF FREE ASSOCIATION WITH THE FED-**  
13 **ERATED STATES OF MICRONESIA**” and inserting  
14 “**COMPACTS OF FREE ASSOCIATION WITH THE**  
15 **FEDERATED STATES OF MICRONESIA AND THE**  
16 **REPUBLIC OF THE MARSHALL ISLANDS**”; and

17 (2) in subsection (a)(1)—

18 (A) by striking “November 17, 2023” and  
19 inserting “February 2, 2024” ;

20 (B) by inserting “, section 103(f)(2) of the  
21 Compact of Free Association Amendments Act  
22 of 2003 (48 U.S.C. 1921b(f)(2)), and sections  
23 211, 213, and 216 of the Compact of Free As-  
24 sociation between the Government of the United  
25 States of America and the Government of the

1 Republic of the Marshall Islands set forth in  
2 section 201(b) of that Act (48 U.S.C. 1921  
3 note; Public Law 108–188)” before “shall,”;

4 (C) by inserting “or the Republic of the  
5 Marshall Islands, as applicable” before “, con-  
6 tinue”; and

7 (D) by striking “of that Compact” and in-  
8 serting “of the applicable Compact”.

9 **SEC. 102. EXTENSION OF AGRICULTURAL PROGRAMS.**

10 (a) EXTENSION.—Except as otherwise provided in  
11 this section and the amendments made by this section,  
12 notwithstanding any other provision of law, the authorities  
13 (including any limitations on the authorities) provided by  
14 each provision of the Agriculture Improvement Act of  
15 2018 (Public Law 115–334; 132 Stat. 4490) and each  
16 provision of law amended by that Act (and for mandatory  
17 programs at such funding levels), as in effect on Sep-  
18 tember 30, 2023, shall continue, and the authorities shall  
19 be carried out, until the later of—

20 (1) September 30, 2024; or

21 (2) the date specified in the provision of that  
22 Act or the provision of law amended by that Act.

23 (b) DISCRETIONARY PROGRAMS.—Programs carried  
24 out using the authorities described in subsection (a) that  
25 are funded by discretionary appropriations (as defined in



1 section 250(c) of the Balanced Budget and Emergency  
2 Deficit Control Act of 1985 (2 U.S.C. 900(c)) shall be  
3 subject to the availability of appropriations.

4 (c) COMMODITY PROGRAMS.—

5 (1) IN GENERAL.—The provisions of law appli-  
6 cable to a covered commodity (as defined in section  
7 1111 of the Agricultural Act of 2014 (7 U.S.C.  
8 9011)), a loan commodity (as defined in section  
9 1201 of that Act (7 U.S.C. 9031)), sugarcane, or  
10 sugar beets for the 2023 crop year pursuant to title  
11 I of that Act (7 U.S.C. 9011 et seq.) and each  
12 amendment made by subtitle C of title I of the Agri-  
13 culture Improvement Act of 2018 (Public Law 115–  
14 334; 132 Stat. 4511) shall be applicable to the 2024  
15 crop year for that covered commodity, loan com-  
16 modity, sugarcane, or sugar beets.

17 (2) DAIRY.—

18 (A) BASE PRODUCTION HISTORY ADJUST-  
19 MENT FOR PARTICIPATING DAIRY OPERATIONS  
20 WITH PRODUCTION OF LESS THAN 5,000,000  
21 POUNDS.—Section 1405(a) of the Agricultural  
22 Act of 2014 (7 U.S.C. 9055(a)) is amended—

23 (i) in paragraph (1), by inserting  
24 “paragraph (4) and” before “subsection  
25 (b)”; and

1 (ii) by adding at the end the fol-  
2 lowing:

3 “(4) BASE PRODUCTION HISTORY ADJUSTMENT  
4 FOR PARTICIPATING DAIRY OPERATIONS WITH PRO-  
5 Duction OF LESS THAN 5,000,000 POUNDS.—

6 “(A) IN GENERAL.—If the amount deter-  
7 mined under paragraph (1) is less than  
8 5,000,000 pounds, the production history of the  
9 dairy operation for dairy margin coverage shall  
10 be equal to—

11 “(i) the amount determined under  
12 paragraph (1); plus

13 “(ii) 75 percent of the amount de-  
14 scribed in subparagraph (B).

15 “(B) AMOUNT.—The amount referred to in  
16 subparagraph (A)(ii) is, with respect to a dairy  
17 operation, the amount equal to—

18 “(i) the production volume of such  
19 dairy operation for the 2019 milk mar-  
20 keting year; minus

21 “(ii) the amount determined under  
22 paragraph (1).”.

23 (B) DAIRY MARGIN COVERAGE.—

24 (i) DURATION.—Section 1409 of the  
25 Agricultural Act of 2014 (7 U.S.C. 9059)

1 is amended by striking “2023” and insert-  
2 ing “2024”.

3 (ii) AVAILABILITY OF PREMIUM DIS-  
4 COUNT.—With respect to coverage for cal-  
5 endar year 2024, section 1407(g) of the  
6 Agricultural Act of 2014 (7 U.S.C.  
7 9057(g)) shall only apply to a participating  
8 dairy operation with respect to which the  
9 premium was reduced in accordance with  
10 that section for calendar year 2023.

11 (C) DAIRY FORWARD PRICING PROGRAM.—  
12 Section 1502(e)(2) of the Food, Conservation,  
13 and Energy Act of 2008 (7 U.S.C. 8772(e)(2))  
14 is amended by striking “2026” and inserting  
15 “2027”.

16 (3) EXTENSION OF PAYMENT AMOUNT.—Sec-  
17 tion 1116(d) of the Agricultural Act of 2014 (7  
18 U.S.C. 9016(d)) is amended, in the matter pre-  
19 ceding paragraph (1), by striking “2018” and in-  
20 serting “2024”.

21 (4) SUSPENSION OF PERMANENT PRICE SUP-  
22 PORT AUTHORITIES.—The provisions of law specified  
23 in—

1 (A) subsections (a) and (b) of section 1602  
2 of the Agricultural Act of 2014 (7 U.S.C.  
3 9092)—

4 (i) shall not be applicable to the 2024  
5 crops of covered commodities (as defined  
6 in section 1111 of that Act (7 U.S.C.  
7 9011)), cotton, and sugar; and

8 (ii) shall not be applicable to milk  
9 through December 31, 2024; and

10 (B) section 1602(c) of that Act (7 U.S.C.  
11 9092(c)) shall not be applicable to the crops of  
12 wheat planted for harvest in calendar year  
13 2024.

14 (d) OTHER PROGRAMS.—

15 (1) CONSERVATION.—

16 (A) GRASSROOTS SOURCE WATER PROTEC-  
17 TION PROGRAM.—Section 12400(b)(3) of the  
18 Food Security Act of 1985 (16 U.S.C. 3839bb-  
19 2(b)(3)) is amended—

20 (i) by striking the period at the end  
21 and inserting “; and”;

22 (ii) by striking “use \$5,000,000” and  
23 inserting the following: “use—  
24 “(A) \$5,000,000”; and

1 (iii) by adding at the end the fol-  
2 lowing:

3 “(B) \$1,000,000 beginning in fiscal year  
4 2024, to remain available until expended.”.

5 (B) VOLUNTARY PUBLIC ACCESS AND  
6 HABITAT INCENTIVE PROGRAM.—Section  
7 1240R(f)(1) of the Food Security Act of 1985  
8 (16 U.S.C. 3839bb–5(f)(1)) is amended—

9 (i) by striking “and” after “2018,”;  
10 and

11 (ii) by inserting “, and \$10,000,000  
12 for fiscal year 2024” before the period at  
13 the end.

14 (C) FERAL SWINE ERADICATION AND CON-  
15 TROL PILOT PROGRAM.—Section 2408(g)(1) of  
16 the Agriculture Improvement Act of 2018 (7  
17 U.S.C. 8351 note; Public Law 115–334) is  
18 amended by inserting “and \$15,000,000 for fis-  
19 cal year 2024” before the period at the end.

20 (2) TRADE.—Section 302(h)(2) of the Bill  
21 Emerson Humanitarian Trust Act (7 U.S.C. 1736f–  
22 1(h)(2)) is amended by striking “2023” and insert-  
23 ing “2024”.

24 (3) NUTRITION.—Section 203D(d)(5) of the  
25 Emergency Food Assistance Act of 1983 (7 U.S.C.

1 7507(d)(5)) is amended by striking “2023” and in-  
2 sserting “2024”.

3 (4) RURAL ECONOMIC DEVELOPMENT PRO-  
4 GRAM.—Section 313B(e)(2) of the Rural Electrifica-  
5 tion Act of 1936 (7 U.S.C. 940c–2(e)(2)) is amend-  
6 ed by striking “and 2023” and inserting “through  
7 2024”.

14 “three” and inserting “4”; and

15 (ii) in subsection (b)(1)—

16 (I) by striking “Of” and insert-  
17 ing the following:

18 “(A) FUNDING.—Of”; and

19 (II) by adding at the end the fol-  
20 lowing:

21 “(B) ADDITIONAL FUNDING.—Not later  
22 than 30 days after the date of enactment of  
23 this subparagraph, of the funds of the Com-  
24 modity Credit Corporation, the Secretary shall  
25 make available to carry out this section

1           \$10,000,000, to remain available until ex-

2           Section 9010(b) of the Farm Security and  
3           Rural Investment Act of 2002 (7 U.S.C.  
4           8110(b)) is amended in paragraphs (1)(A) and  
5           (2)(A) by striking “2023” each place it appears  
6           and inserting “2024”.

7           (7) HORTICULTURE.—

8           (A) ORGANIC PRODUCTION AND MARKET  
9           DATA INITIATIVES.—Section 7407(d)(1) of the  
10          Farm Security and Rural Investment Act of  
11          2002 (7 U.S.C. 5925c(d)(1)) is amended—

12                 (i) in subparagraph (A), by striking  
13                 “and” at the end;

14                 (ii) in subparagraph (B), by striking  
15                 the period at the end and inserting “;  
16                 and”; and

17                 (iii) by adding at the end the fol-  
18                 lowing:

19                 “(C) \$1,000,000 for fiscal year 2024.”.

20          (B) MODERNIZATION AND IMPROVEMENT  
21          OF INTERNATIONAL TRADE TECHNOLOGY SYS-  
22          TEMS AND DATA COLLECTION.—Section  
23          2123(c)(4) of the Organic Foods Production  
24          Act of 1990 (7 U.S.C. 6522(c)(4)) is amended,  
25          in the matter preceding subparagraph (A), by

1 inserting “and \$1,000,000 for fiscal year 2024”  
2 after “2019”.

3 (C) NATIONAL ORGANIC CERTIFICATION  
4 COST-SHARE PROGRAM.—Section  
5 10606(d)(1)(C) of the Farm Security and  
6 Rural Investment Act of 2002 (7 U.S.C.  
7 6523(d)(1)(C)) is amended by striking “and  
8 2023” and inserting “through 2024”.

9 (D) MULTIPLE CROP AND PESTICIDE USE  
10 SURVEY.—Section 10109(c)(1) of the Agri-  
11 culture Improvement Act of 2018 (Public Law  
12 115–334; 132 Stat. 4906) is amended by in-  
13 serting “and \$100,000 for fiscal year 2024”  
14 after “2019”.

15 (8) MISCELLANEOUS.—

16 (A) PIMA AGRICULTURE COTTON TRUST  
17 FUND.—Section 12314 of the Agricultural Act  
18 of 2014 (7 U.S.C. 2101 note; Public Law 113–  
19 79) is amended—

20 (i) in subsection (b), in the matter  
21 preceding paragraph (1), by striking  
22 “2023” and inserting “2024”; and

23 (ii) in subsection (h), by striking  
24 “2023” and inserting “2024”.

1 (B) AGRICULTURE WOOL APPAREL MANU-  
2 FACTURERS TRUST FUND.—Section 12315 of  
3 the Agricultural Act of 2014 (7 U.S.C. 7101  
4 note; Public Law 113–79) is amended by strik-  
5 ing “2023” each place it appears and inserting  
6 “2024”.

7 (C) WOOL RESEARCH AND PROMOTION.—  
8 Section 12316(a) of the Agricultural Act of  
9 2014 (7 U.S.C. 7101 note; Public Law 113–79)  
10 is amended by striking “2023” and inserting  
11 “2024”.

12 (D) EMERGENCY CITRUS DISEASE RE-  
13 SEARCH AND DEVELOPMENT TRUST FUND.—  
14 Section 12605(d) of the Agriculture Improve-  
15 ment Act of 2018 (7 U.S.C. 7632 note; Public  
16 Law 115–334) is amended by striking “2023”  
17 and inserting “2024”.

18 (E) SHEEP PRODUCTION AND MARKETING  
19 GRANT PROGRAM.—Section 209(e) of the Agri-  
20 cultural Marketing Act of 1946 (7 U.S.C.  
21 1627a(c)) is amended by inserting “and  
22 \$400,000 for fiscal year 2024,” after “2019,”.

23 (9) EXCEPTIONS.—Subsection (a) shall not  
24 apply with respect to mandatory funding under the  
25 following provisions of law:

1 (A) Section 1614(c)(4) of the Agricultural  
2 Act of 2014 (7 U.S.C. 9097(c)(4)).

3 (B) Subparagraphs (A) and (B) of section  
4 1241(a)(1) of the Food Security Act of 1985  
5 (16 U.S.C. 3841(a)(1)).

6 (e) REPORTS.—

7 (1) IN GENERAL.—Subject to paragraph (2),  
8 any requirement under a provision of law described  
9 in subsection (a) to submit a report on a recurring  
10 basis, and the final report under which was required  
11 to be submitted during fiscal year 2023, shall con-  
12 tinue, and the requirement shall be carried out, on  
13 the same recurring basis, until the later of the dates  
14 specified in paragraphs (1) and (2) of that sub-  
15 section.

16 (2) APPROPRIATIONS REQUIRED.—If discre-  
17 tionary appropriations (as defined in section 250(c)  
18 of the Balanced Budget and Emergency Deficit Con-  
19 trol Act of 1985 (2 U.S.C. 900(c))) are required to  
20 carry out a reporting requirement described in para-  
21 graph (1), the application of that paragraph to that  
22 reporting requirement shall be subject to the avail-  
23 ability of appropriations.

24 (f) RESCISSION.—Of the unobligated balances of  
25 amounts made available under section 9003(g)(1)(A) of
