## A BILL

To amend the Help America Vote Act of 2002 to prohibit the Election Assistance Commission from making payments under such Act to States and jurisdictions which fail to meet certain standards to protect the integrity and certainty of elections for Federal office, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “One Citizen One Vote  
5 Act”.

1 **SEC. 2. PROHIBITING PAYMENTS TO STATES FAILING TO**  
2 **MEET ELECTION INTEGRITY AND CERTAINTY**  
3 **STANDARDS.**

4 (a) PROHIBITION.—Title IX of the Help America  
5 Vote Act of 2002 (52 U.S.C. 21141 et seq.) is amended  
6 by adding at the end the following new section:

7 **“SEC. 907. PROHIBITING PAYMENTS TO STATES AND JURIS-**  
8 **DICTIONS FAILING TO MEET ELECTION IN-**  
9 **TEGRITY AND CERTAINTY STANDARDS.**

10 “The Commission may not make any payment under  
11 this Act to any State or jurisdiction unless the State or  
12 jurisdiction certifies to the Commission each of the fol-  
13 lowing:

14 “(1) The State or jurisdiction does not permit  
15 an individual to cast a ballot in an election for Fed-  
16 eral office unless—

17 “(A) in the case of an individual who de-  
18 sires to cast a ballot in person, the individual  
19 presents to the appropriate election official a  
20 current and valid photo identification of the in-  
21 dividual; or

22 “(B) in the case of an individual who de-  
23 sires to cast a ballot by mail, the individual in-  
24 cludes with the ballot a copy of a current and  
25 valid photo identification of the individual.

1           “(2) The State or jurisdiction does not accept  
2 a voted absentee ballot in an election for Federal of-  
3 fice which is delivered in person to an election offi-  
4 cial by any individual other than the voter to whom  
5 the ballot was transmitted, other than an individual  
6 described as follows:

7                   “(A) An election official while engaged in  
8 official duties as authorized by law.

9                   “(B) An employee of the United States  
10 Postal Service while engaged in official duties  
11 as authorized by law.

12                   “(C) Any other individual who is allowed  
13 by law to collect and transmit United States  
14 mail, while engaged in official duties as author-  
15 ized by law.

16           “(3) The State or jurisdiction does not provide  
17 any drop box into which an individual may deliver  
18 a voted ballot, other than a drop box which is lo-  
19 cated at the office of a State or local election offi-  
20 cial.

21           “(4) The State or jurisdiction does not deliver  
22 an absentee or other mail-in ballot to any individual  
23 who does not request the delivery of such a ballot.

24           “(5) The State or jurisdiction does not permit  
25 any individual who is not a citizen of the United

1 States to register to vote or vote in any election for  
2 public office, or any ballot initiative or referendum,  
3 held in the State or jurisdiction.”.

4 (b) CLERICAL AMENDMENT.—The table of contents  
5 of such Act is amended by adding at the end of the items  
6 relating to title IX the following:

“Sec. 907. Prohibiting payments to States and jurisdictions failing to meet  
election integrity and certainty standards.”.

7 (c) EFFECTIVE DATE.—The amendments made by  
8 this section shall apply with respect to payments made on  
9 or after the date of the enactment of this Act.
