A BILL

To amend the STOCK Act to require the public availability of financial disclosure forms of certain special consultants and information relating to certain confidential filers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Financial Account-
5 ability for Uniquely Compensated Individuals Act” or the
6 “FAUCI Act”.

1 **SEC. 2. PUBLIC AVAILABILITY OF FINANCIAL DISCLOSURE**
2 **FORMS OF CERTAIN SPECIAL CONSULTANTS**
3 **AND INFORMATION RELATING TO CERTAIN**
4 **CONFIDENTIAL FILERS.**

5 (a) IN GENERAL.—Section 11(b)(1) of the STOCK
6 Act (Public Law 112–105; 5 U.S.C. App. 105 note) is
7 amended—

8 (1) in the matter preceding subparagraph (A),
9 by inserting “, through databases maintained on the
10 official website of the Office of Government Ethics”
11 after “enable”;

12 (2) by striking the undesignated matter fol-
13 lowing subparagraph (B); and

14 (3) in subparagraph (B)—

15 (A) in each of clauses (i) and (iii), by
16 striking the comma at the end of the clause and
17 inserting a semicolon;

18 (B) in clause (i), by inserting “any officer
19 or employee in the executive branch (including
20 a special Government employee (as defined in
21 section 202 of title 18, United States Code) and
22 any special consultant appointed under section
23 207(f) of the Public Health Service Act (42
24 U.S.C. 209(f))) whose annual rate of pay is
25 equal to or greater than the annual rate of pay
26 for a Member of Congress under section 601(a)

1 of the Legislative Reorganization Act of 1946
2 (2 U.S.C. 4501),” before “and any officer”;

3 (C) in clause (ii), by striking “, and” at
4 the end and inserting a semicolon;

5 (D) in clause (iii), by adding “and” at the
6 end; and

7 (E) by inserting after clause (iii) the fol-
8 lowing:

9 “(iv) a list of the name, position, and
10 salary of each individual whose annual rate
11 of pay is equal to or greater than the an-
12 nual rate of pay for a Member of Congress
13 under section 601(a) of the Legislative Re-
14 organization Act of 1946 (2 U.S.C. 4501)
15 that filed a confidential financial disclosure
16 report under section 107(a)(1) of the Eth-
17 ics in Government Act of 1978 (5 U.S.C.
18 App.), including a description of the spe-
19 cific type of information included in the fi-
20 nancial disclosure report filed by the indi-
21 vidual.”.

22 (b) APPLICABLE DEADLINES.—The Director of the
23 Office of Government Ethics shall publish on the public
24 website of the Office of Government Ethics any informa-

1 tion with respect to which public access is required by an
2 amendment made by subsection (a)—

3 (1) not later than 45 days after the date of en-
4 actment of this Act, in the case of information re-
5 quired for calendar year 2020;

6 (2) not later than 180 days after the date of
7 enactment of this Act, in the case of information re-
8 quired for each of calendar years 2017 through
9 2019;

10 (3) not later than 1 year after the date of en-
11 actment of this Act, in the case of information re-
12 quired for each of calendar years 2014 through
13 2016;

14 (4) not later than May 15, 2022, in the case of
15 information required for calendar year 2021;

16 (5) not later than 30 days after the date on
17 which the financial disclosure is filed, in the case of
18 information required by an amendment made by
19 subsection (a)(3)(B) for calendar year 2022 and
20 each calendar year thereafter; and

21 (6) not later than May 15 of the subsequent
22 calendar year, in the case of information required by
23 an amendment made by subsection (a)(3)(E) for cal-
24 endar year 2022 and each calendar year thereafter.
