## A BILL

To amend the Help America Vote Act of 2002 to permit an individual who is subject to a requirement to present identification as a condition of voting in an election for Federal office to meet such requirement by pre-

senting a sworn written statement attesting to the individual’s identification, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “America Votes Act of  
 5 2019”.

6 **SEC. 2. PERMITTING USE OF SWORN WRITTEN STATEMENT**  
 7                   **TO MEET IDENTIFICATION REQUIREMENTS**  
 8                   **FOR VOTING.**

9       (a) PERMITTING USE OF STATEMENT.—Title III of  
 10 the Help America Vote Act of 2002 (52 U.S.C. 21081 et  
 11 seq.) is amended by inserting after section 303 the fol-  
 12 lowing new section:

13 **“SEC. 303A. PERMITTING USE OF SWORN WRITTEN STATE-**  
 14                   **MENT TO MEET IDENTIFICATION REQUIRE-**  
 15                   **MENTS.**

16       “(a) USE OF STATEMENT.—

17               “(1) IN GENERAL.—Except as provided in sub-  
 18 section (c), if a State has in effect a requirement  
 19 that an individual present identification as a condi-  
 20 tion of receiving and casting a ballot in an election  
 21 for Federal office, the State shall permit the indi-  
 22 vidual to meet the requirement—

23                   “(A) in the case of an individual who de-  
 24 sires to vote in person, by presenting the appro-

1           appropriate State or local election official with a  
2           sworn written statement, signed by the indi-  
3           vidual under penalty of perjury, attesting to the  
4           individual's identification and attesting that the  
5           individual is registered to vote in the election;  
6           or

7           “(B) in the case of an individual who de-  
8           sires to vote by mail, by submitting with the  
9           ballot the statement described in subparagraph  
10          (A).

11          “(2) PROVIDING PRE-PRINTED COPY OF STATE-  
12          MENT.—A State which is subject to paragraph (1)  
13          shall—

14                 “(A) prepare a pre-printed version of the  
15                 statement described in paragraph (1)(A) which  
16                 includes a blank space for an individual to pro-  
17                 vide a name and signature;

18                 “(B) make copies of the pre-printed  
19                 version available at polling places for election  
20                 officials to distribute to individuals who desire  
21                 to vote in person; and

22                 “(C) include a copy of the pre-printed  
23                 version with each blank absentee or other ballot  
24                 transmitted to an individual who desires to vote  
25                 by mail.

1       “(b) REQUIRING USE OF REGULAR BALLOT.—A  
 2 State may not require an individual who presents or sub-  
 3 mits a sworn written statement in accordance with sub-  
 4 section (a)(1) to cast a provisional ballot in the election  
 5 under section 302.

6       “(c) EXCEPTION FOR FIRST-TIME VOTERS REG-  
 7 ISTERING BY MAIL.—Subsections (a) and (b) do not apply  
 8 with respect to any individual described in paragraph (1)  
 9 of section 303(b) who is required to meet the requirements  
 10 of paragraph (2) of such section.”.

11       (b) CONFORMING AMENDMENT RELATING TO EN-  
 12 FORCEMENT.—Section 401 of such Act (52 U.S.C. 21111)  
 13 is amended by striking “and 303” and inserting “303, and  
 14 303A”.

15       (c) CLERICAL AMENDMENT.—The table of contents  
 16 of such Act is amended by inserting after the item relating  
 17 to section 303 the following new item:

“Sec. 303A. Permitting use of sworn written statement to meet identification requirements.”.

18 **SEC. 3. REQUIRING STATES TO INCLUDE INFORMATION ON**  
 19 **USE OF SWORN WRITTEN STATEMENT IN**  
 20 **VOTING INFORMATION MATERIAL POSTED AT**  
 21 **POLLING PLACES.**

22       Section 302(b)(2) of the Help America Vote Act of  
 23 2002 (52 U.S.C. 21082(b)(2)) is amended—

1           (1) by striking “and” at the end of subpara-  
2           graph (E);

3           (2) by striking the period at the end of sub-  
4           paragraph (F) and inserting “; and”; and

5           (3) by adding at the end the following new sub-  
6           paragraph:

7                   “(G) in the case of a State that has in ef-  
8                   fect a requirement that an individual present  
9                   identification as a condition of receiving and  
10                  casting a ballot in an election for Federal office,  
11                  information on how an individual may meet  
12                  such requirement by presenting a sworn written  
13                  statement in accordance with section 303A.”.

14 **SEC. 4. EFFECTIVE DATE.**

15           The amendments made by this Act shall apply with  
16           respect to elections occurring on or after the date of the  
17           enactment of this Act.
