## A BILL

To amend title 38, United States Code, to clarify that caregivers for veterans with serious illnesses are eligible for assistance and support services provided by the Secretary of Veterans Affairs, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Support Our Services  
5 to Veterans Caregivers Act” or the “S.O.S. Veterans  
6 Caregivers Act”.

1 **SEC. 2. IMPROVEMENTS TO SERVICES PROVIDED TO CARE-**  
2 **GIVERS OF VETERANS.**

3 (a) CAREGIVERS OF VETERANS WITH SERIOUS ILL-  
4 NESSES.—Paragraph (2)(B) of section 1720G(a) of title  
5 38, United States Code, is amended by inserting “illness  
6 or” after “serious” each place it appears.

7 (b) ASSESSING CAREGIVER AND VETERAN BURDEN  
8 AND SATISFACTION.—

9 (1) SURVEY.—Paragraph (3)(A)(ii) of such sec-  
10 tion is amended—

11 (A) in subclause (V), by striking “; and”  
12 and inserting a semicolon;

13 (B) in subclause (VI)(bb), by striking the  
14 period at the end and inserting “; and”; and

15 (C) by adding at the end the following new  
16 subclause:

17 “(VII) not less than annually, a multi-  
18 dimensional assessment to measure, in both ob-  
19 jective and subjective terms, the burden and  
20 strain felt by the family caregiver.”.

21 (2) REPORTS.—Section 101(c)(2)(B) of the  
22 Caregivers and Veterans Omnibus Health Services  
23 Act of 2010 (Public Law 111–163; 38 U.S.C.  
24 1720G note) is amended—

25 (A) in clause (ii), by striking “; and” and  
26 inserting a semicolon;

1 (B) in clause (iii), by striking the period at  
2 the end and inserting “; and”; and

3 (C) by adding at the end the following new  
4 clause:

5 “(iv) a description of the satisfaction  
6 experienced by caregivers and veterans  
7 with respect to such program, including  
8 any findings regarding whether such pro-  
9 gram reduces the burden and strain felt by  
10 caregivers.”.

11 (c) EFFECTIVE DATE.—The amendments made by  
12 subsection (a) shall apply with respect to services provided  
13 after the date of the enactment of this Act.
