A BILL

To amend title XVIII of the Social Security Act to extend the special election period under part C of the Medicare program for certain deemed individuals enrolled in a reasonable cost reimbursement contract to certain non-deemed individuals enrolled in such contract.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Empowering Seniors’*
5 *Enrollment Decision Act of 2018”.*

6 **SEC. 2. EXTENDING THE SPECIAL ELECTION PERIOD**
7 **UNDER PART C OF THE MEDICARE PROGRAM**
8 **FOR CERTAIN DEEMED INDIVIDUALS EN-**
9 **ROLLED IN A REASONABLE COST REIMBURSE-**
10 **MENT CONTRACT TO CERTAIN NONDEEMED**
11 **INDIVIDUALS ENROLLED IN SUCH CONTRACT.**

12 *Section 1851(e)(2)(F) of the Social Security Act (42*
13 *U.S.C. 1395w–21(e)(2)(F)) is amended—*

14 *(1) in the header, by striking “DEEMED ELEC-*
15 *TIONS” and inserting “INDIVIDUALS ENROLLED IN A*
16 *REASONABLE COST REIMBURSEMENT CONTRACT”; and*

17 *(2) by amending clause (i) to read as follows:*

18 *“(i) IN GENERAL.—*

19 *“(I) ELECTION PERIOD.—At any*
20 *time during the period beginning after*
21 *the last day of the annual, coordinated*
22 *election period under paragraph (3)*
23 *occurring during an applicable plan*
24 *year and ending on the last day of*
25 *February of the first plan year fol-*

1 *lowing such applicable plan year, an*
2 *individual who is an eligible indi-*
3 *vidual (as defined in subclause (II))*
4 *with respect to such applicable plan*
5 *year may change the election under*
6 *subsection (a)(1) (including changing*
7 *the MA plan or MA–PD plan in which*
8 *the individual is enrolled) for such*
9 *first plan year.*

10 *“(II) ELIGIBLE INDIVIDUAL.—In*
11 *this clause, the term ‘eligible indi-*
12 *vidual’ means, with respect to a plan*
13 *year, an individual enrolled in a rea-*
14 *sonable cost reimbursement contract*
15 *under section 1876(h) that was ex-*
16 *tended or renewed for the last reason-*
17 *able cost reimbursement contract year*
18 *of the contract (as described in sub-*
19 *clause (I) of section 1876(h)(5)(C)(iv))*
20 *pursuant to such section.”.*
