A BILL

To save at least \$10,000,000,000 by consolidating some duplicative and overlapping Government programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CONSOLIDATING UNNECESSARY DUPLICATIVE**
4 **AND OVERLAPPING GOVERNMENT PRO-**
5 **GRAMS.**

6 Notwithstanding any other provision of law, not later
7 than 150 days after the date of enactment of this Act,

1 the Director of the Office of Management and Budget
2 shall coordinate with the heads of the relevant department
3 and agencies to—

4 (1) use available administrative authority to
5 eliminate, consolidate, or streamline Government
6 programs and agencies with duplicative and overlap-
7 ping missions identified in—

8 (A) the February 2012 Government Ac-
9 countability Office report to Congress, entitled
10 “Opportunities to Reduce Duplication, Overlap
11 and Fragmentation, Achieve Savings, and En-
12 hance Revenue” (GAO–12–342SP); and

13 (B) the March 2011 Government Account-
14 ability Office report to Congress, entitled “Op-
15 portunities to Reduce Potential Duplication in
16 Government Programs, Save Tax Dollars, and
17 Enhance Revenue” (GAO–11–318SP) and
18 apply the savings towards deficit reduction;

19 (2) identify and report to Congress any legisla-
20 tive changes required to further eliminate, consoli-
21 date, or streamline Government programs and agen-
22 cies with duplicative and overlapping missions identi-
23 fied in—

24 (A) the February 2012 Government Ac-
25 countability Office report to Congress, entitled

1 “Opportunities to Reduce Duplication, Overlap
2 and Fragmentation, Achieve Savings, and En-
3 hance Revenue” (GAO–12–342SP); and

4 (B) the March 2011 Government Account-
5 ability Office report to Congress, entitled “Op-
6 portunities to Reduce Potential Duplication in
7 Government Programs, Save Tax Dollars, and
8 Enhance Revenue” (GAO–11–318SP);

9 (3) determine the total cost savings that shall
10 result to each agency, office, and department from
11 the actions described in paragraph (1); and

12 (4) rescind from the appropriate accounts the
13 amount greater of—

14 (A) \$10,000,000,000; or

15 (B) the total amount of cost savings esti-
16 mated by paragraph (3).
