## A BILL

To amend the Alaska Tourism Restoration Act to revise the authority for voyages deemed to have made a stop in a port or place of Canada and deemed a foreign voyage for the purposes of the law of the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Alaska Tourism Res-  
5 toration Extension Act”.

1 **SEC. 2. VOYAGES DEEMED FOREIGN.**

2 (a) DEFINITIONS.—Subsection (a) of section 2 of the  
3 Alaska Tourism Restoration Act (Public Law 117–14) is  
4 amended to read as follows:

5 “(a) DEFINITIONS.—In this section:

6 “(1) COVERED CRUISE SHIP.—

7 “(A) IN GENERAL.—The term ‘covered  
8 cruise ship’ means a vessel carrying passengers  
9 for hire that—

10 “(i) is listed in subparagraph (B); or

11 “(ii) only in the event that a vessel  
12 listed in subparagraph (B) experiences a  
13 mechanical or operational issue, is deter-  
14 mined by the Secretary of the department  
15 in which the Coast Guard is operating to  
16 take the place of such vessel as a direct  
17 substitute of such vessel.

18 “(B) LIST.—A vessel listed in this sub-  
19 paragraph is any of the following:

17 “(2) PASSENGER FOR HIRE.—The term ‘pas-  
18 senger for hire’ has the meaning given the term in  
19 section 2101 of title 46, United States Code.”.

20 (b) CRITERIA.—Section 2(b) of the Alaska Tourism  
21 Restoration Act (Public Law 117–14) is amended in para-  
22 graph (2), by striking “February 28, 2022” and inserting  
23 “February 28, 2023”.

24 (c) APPLICABILITY; DURATION.—Section 2 of the  
25 Alaska Tourism Restoration Act (Public Law 117–14) is

1 amended by striking subsections (f) and (g) and inserting  
2 the following:

3 “(f) APPLICABILITY.—This section shall apply only  
4 during any period during which covered cruise ships are  
5 prohibited by the Government of Canada, any political  
6 subdivision of Canada, or any port or province of Canada,  
7 from berthing or docking in Canadian waters of the Pa-  
8 cific Coast due to the COVID–19 pandemic.”.
