## AN ACT

To amend the Elder Abuse Prevention and Prosecution Act to improve the prevention of elder abuse and exploitation of individuals with Alzheimer's disease and related dementias.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Promoting Alzheimer’s  
3 Awareness to Prevent Elder Abuse Act”.

4 **SEC. 2. ADDRESSING ALZHEIMER’S DISEASE IN BEST PRACTICES.**  
5 **TICES.**

6 (a) IN GENERAL.—Section 101(b) of the Elder Abuse  
7 Prevention and Prosecution Act (34 U.S.C. 21711(b)) is  
8 amended—

9 (1) by redesignating subparagraphs (A), (B),  
10 and (C) of paragraph (2) as clauses (i), (ii), and  
11 (iii), respectively, and adjusting the margin accord-  
12 ingly;

13 (2) by redesignating paragraphs (1), (2), and  
14 (3) as subparagraphs (A), (B), and (C), respectively,  
15 and adjusting the margin accordingly;

16 (3) by striking “Not later than” and inserting  
17 the following:

18 “(1) IN GENERAL.—Not later than”;

19 (4) in paragraph (1)(B), as so redesignated—

20 (A) in clause (ii), by inserting “, including  
21 witnesses who have Alzheimer’s disease and re-  
22 lated dementias” after “other legal issues”; and

23 (B) in clause (iii), by striking “elder abuse  
24 cases,” and inserting “elder abuse cases (in-  
25 cluding victims and witnesses who have Alz-  
26 heimer’s disease and related dementias),”; and

1 (5) by adding at the end the following:

2 “(2) TRAINING MATERIALS.—

3 “(A) IN GENERAL.—In creating or com-  
4 piling replication guides and training materials  
5 under paragraph (1)(B), the Elder Justice Co-  
6 ordinator shall consult with the Secretary of  
7 Health and Human Services, State, local, and  
8 Tribal adult protective services, aging, social,  
9 and human services agencies, Federal, State,  
10 local, and Tribal law enforcement agencies, and  
11 nationally recognized nonprofit associations  
12 with relevant expertise, as appropriate.

13 “(B) UPDATING.—The Elder Justice Coor-  
14 dinator shall—

15 “(i) review the best practices identi-  
16 fied and replication guides and training  
17 materials created or compiled under para-  
18 graph (1)(B) to determine if the replica-  
19 tion guides or training materials require  
20 updating; and

21 “(ii) perform any necessary updating  
22 of the replication guides or training mate-  
23 rials.”.

24 (b) APPLICABILITY.—The amendments made by sub-  
25 section (a) shall—

1           (1) take effect on the date of enactment of this  
2     Act; and

3           (2) apply on and after the date that is 1 year  
4     after the date of enactment of this Act.

5 **SEC. 3. REPORT ON OUTREACH.**

6           (a) IN GENERAL.—Section 101(c)(2) of the Elder  
7     Abuse Prevention and Prosecution Act (34 U.S.C.  
8     21711(c)(2)) is amended—

9           (1) by redesignating subparagraphs (A) through  
10     (D) as clauses (i) through (iv), respectively, and ad-  
11     justing the margin accordingly;

12           (2) by striking “a report detailing” and insert-  
13     ing the following: “a report—

14                 “(A) detailing”; and

15           (3) by adding at the end the following:

16                 “(B) with respect to the report by the At-  
17     torney General, including a link to the publicly  
18     available best practices identified under sub-  
19     section (b)(1)(B) and the replication guides and  
20     training materials created or compiled under  
21     such subsection.”.

22           (b) APPLICABILITY.—The amendments made by sub-  
23     section (a) shall apply with respect to the report under  
24     section 101(c)(2) of the Elder Abuse Prevention and Pros-  
25     ecution Act (34 U.S.C. 21711(c)(2)) submitted during the

1 second year beginning after the date of enactment of this  
2 Act, and each year thereafter.
