A BILL

To amend title 18, United States Code, to extend to private or commercial interstate carriers the same protections enjoyed by letter and mail carriers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Porch Pirates Act of
5 2022”.

1 **SEC. 2. SENSE OF CONGRESS.**

2 It is the sense of Congress that Congress has the au-
3 thority to extend to private or commercial interstate car-
4 riers the same protections enjoyed by letter and mail car-
5 riers pursuant to its authority to regulate interstate com-
6 merce.

7 **SEC. 3. PRIVATE OR COMMERCIAL INTERSTATE CARRIER**
8 **PROTECTIONS.**

9 (a) OBSTRUCTION OF CORRESPONDENCE.—Section
10 1702 of title 18, United States Code, is amended—

11 (1) by inserting after “any post office” each
12 place it appears the following: “, private or commer-
13 cial interstate carrier facility,”;

14 (2) by inserting after “authorized depository for
15 mail matter” the following: “or private or commer-
16 cial interstate carrier drop off”;

17 (3) by inserting after “letter or mail carrier”
18 each place it appears the following: “or private or
19 commercial interstate carrier”;

20 (4) by inserting after “or authorized deposi-
21 tory” the following: “or private or commercial inter-
22 state carrier drop off”.

23 (b) THEFT OR RECEIPT OF STOLEN MAIL MATTER
24 GENERALLY.—Section 1708 of title 18, United States
25 Code, is amended—

1 (1) by inserting after “station thereof” the fol-
2 lowing: “, or any private or commercial interstate
3 carrier facility”;

4 (2) by inserting “or private or commercial
5 interstate carrier” before “route”;

6 (3) by inserting after “other authorized deposi-
7 tory for mail matter” the following: “or private or
8 commercial interstate carrier drop off”;

9 (4) by striking “or other authorized depository
10 of mail matter” and inserting “or other authorized
11 depository for mail matter or private or commercial
12 interstate carrier drop off”; and

13 (5) by inserting after “mail carrier” the fol-
14 lowing: “or private or commercial interstate carrier”.
