A BILL

To direct the Secretary of Veterans Affairs to implement a system or process to actively monitor the veteran self-service and data transmission functions of the main internet website of the Department of Veterans Affairs for certain adverse events, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Department of Veterans*
5 *Affairs Watching over Electronic Benefits Act” or the “VA*
6 *WEB Act”.*

7 **SEC. 2. SYSTEM OR PROCESS TO ACTIVELY MONITOR CER-**
8 **TAIN FUNCTIONS OF THE COVERED WEBSITE**
9 **FOR ADVERSE EVENTS.**

10 (a) *IN GENERAL.—Not later than one year after the*
11 *date of the enactment of this Act, the Secretary of Veterans*
12 *Affairs shall develop and implement a system or process*
13 *to actively monitor certain functions of the covered website,*
14 *including covered features and any underlying interface or*
15 *system, for adverse events. The Secretary may use the au-*
16 *thority under section 701(a) of the Sergeant First Class*
17 *Heath Robinson Honoring our Promise to Address Com-*
18 *prehensive Toxics Act of 2022 (Public Law 117–168; 38*
19 *U.S.C. 324 note) to carry out this subsection.*

20 (b) *SYSTEM OR PROCESS REQUIREMENTS.—The Sec-*
21 *retary shall ensure that the system or process developed*
22 *under subsection (a) is designed to monitor, and log and*
23 *store data, with respect to—*

24 (1) *the volume of traffic to the covered website;*

1 (2) the number of submissions made using a cov-
2 ered feature;
3 (3) software updates or other modifications to a
4 covered feature or underlying interface or system;
5 (4) needs, deficiencies, or obsolescence of a cov-
6 ered feature or underlying interface or system;
7 (5) adverse events, including—
8 (A) the date and time of any such adverse
9 event;
10 (B) the number of users of the covered
11 website who were affected by the adverse event;
12 (C) the number of submissions affected by
13 the adverse event; and
14 (D) any factor related to an underlying
15 interface or system that caused or contributed to
16 the adverse event; and
17 (6) any other factors, as determined by the Sec-
18 retary.

19 (c) NOTICE AND REPORT REGARDING CERTAIN AD-
20 VERSE EVENTS.—

21 (1) NOTICE.—In the case of any significant ad-
22 verse event affecting the covered website, not later
23 than 30 days after the date of such event, the Sec-
24 retary shall submit to the Committees on Veterans'
25 Affairs of the Senate and House of Representatives

1 *notice of the event, including a description of the*
2 *event.*

3 (2) *REPORT.—Not later than 30 days after re-*
4 *ceiving a request from the Chair of the Committee on*
5 *Veterans' Affairs of the Senate or the Chair of the*
6 *Committee on Veterans' Affairs of the House of Rep-*
7 *resentatives for a report about an adverse event, in-*
8 *cluding a significant adverse event, the Secretary*
9 *shall submit to the Committees on Veterans' Affairs of*
10 *the Senate and the House of Representatives a report*
11 *on the adverse event covered by the request. Each such*
12 *report shall include—*

13 (A) *a description of the adverse event;*
14 (B) *the date and time when the adverse*
15 *event began and ended;*
16 (C) *the number of users of the covered*
17 *website who were affected;*
18 (D) *the number of submissions made using*
19 *a covered feature that were affected; and*
20 (E) *a description of any underlying inter-*
21 *face or system that was affected.*

22 (3) *SUNSET.—The requirements under this sub-*
23 *section shall expire on the date that is seven years*
24 *after the date of the enactment of this Act.*

1 (d) *REPORT REGARDING EXERCISE OF CERTAIN AU-*
2 *THORITY.*—*If the Secretary exercises authority under sec-*
3 *tion 701(a) of the Sergeant First Class Heath Robinson*
4 *Honoring our Promise to Address Comprehensive Toxics*
5 *Act of 2022 (Public Law 117–168; 38 U.S.C. 324 note) to*
6 *carry out subsection (a), not later than 30 days after the*
7 *date on which the Secretary first exercises such authority*
8 *for such purpose, the Secretary shall submit to the Commit-*
9 *tees on Veterans’ Affairs of the Senate and the House of*
10 *Representatives and the Committees on Appropriations of*
11 *the Senate and the House of Representatives a report about*
12 *the exercise of such authority. Such report shall include—*

13 (1) *the cost of implementing the system or proc-*
14 *ess developed under subsection (a);*

15 (2) *a description of any modernization or re-*
16 *placement of an underlying interface or system nec-*
17 *essary to implement the system or process;*

18 (3) *an identification of any ways in which the*
19 *covered website and any underlying interface or sys-*
20 *tem is susceptible to any adverse event; and*

21 (4) *a description of how the Secretary plans to*
22 *eliminate or mitigate, to the extent possible, any such*
23 *susceptibility.*

24 (e) *TESTING STRATEGY.*—*Not later than one year after*
25 *the date of the enactment of this Act, the Assistant Secretary*

1 *for Information and Technology of the Department of Vet-*
2 *erans Affairs shall submit to the Committees on Veterans'*
3 *Affairs of the Senate and the House of Representatives a*
4 *strategy to reduce the occurrence of adverse events by im-*
5 *proving testing for each modification or software update to*
6 *a covered feature or underlying system or interface.*

7 (f) *DEFINITIONS.—In this section:*

8 (1) *The term “adverse event” means, with respect*
9 *to the covered website, including covered features—*

10 (A) *a failure to properly receive or process*
11 *a submission;*

12 (B) *a system outage;*

13 (C) *an error in an underlying interface or*
14 *system that prevents the transmission of data;*

15 (D) *a deficiency in information storage ca-*
16 *pacity;*

17 (E) *a loss of data;*

18 (F) *a presentation of incorrect information;*

19 (G) *an error regarding a status notifica-*
20 *tion; or*

21 (H) *any similar event that affects a func-*
22 *tion of the covered website, as determined by the*
23 *Secretary.*

24 (2) *The term “covered feature” means any fea-*
25 *ture or function of the covered website for use in the*

1 *facilitation of the application, maintenance, or re-*
2 *ceipt of benefits under the laws administered by the*
3 *Secretary.*

4 (3) *The term “covered website” means the main*
5 *internet website of the Department of Veterans Af-*
6 *fairs.*

7 (4) *The term “significant adverse event”, with*
8 *respect to the covered website, including covered fea-*
9 *tures, means an adverse event that affects users of, or*
10 *submissions to, the covered website for a period of 24*
11 *hours or longer.*

12 (5) *The term “underlying interface or system”*
13 *means—*

14 (A) *any information technology system that*
15 *transmits data through, or accepts data from, a*
16 *covered feature; or*

17 (B) *any mechanism through which any*
18 *such information technology system connects and*
19 *interacts with the covered website.*

20 **SEC. 3. ADJUSTMENT OF CERTAIN LOAN FEES.**

21 *The loan fee table in section 3729(b)(2) of title 38,*
22 *United States Code, is amended by striking “November 15,*
23 *2031” each place it appears and inserting “November 28,*
24 *2031”.*
