Mr. ALLEN (for himself and Mr. DESAULNIER) introduced the following bill; which was referred to the Committee on Education and the Workforce

A BILL

To amend the Workforce Innovation and Opportunity Act to authorize a study to review specific outcomes of entrepreneurial skills development programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. STATE WORKFORCE DEVELOPMENT BOARD.**

4 Section 101(d)(3)(D) of the Workforce Innovation
5 and Opportunity Act (29 U.S.C. 3111(d)(3)(D)) is
6 amended—

7 (1) by striking “and jobseekers” and inserting
8 “jobseekers, and entrepreneurs”; and

1 (2) by inserting “and entrepreneurial skills de-
2 velopment and microenterprise services” after “occu-
3 pations”.

4 **SEC. 2. IDENTIFICATION OF ELIGIBLE PROVIDERS OF**
5 **TRAINING SERVICES.**

6 Section 122(a)(2)(C) of the Workforce Innovation
7 and Opportunity Act (29 U.S.C. 3152(a)(2)(C)) is amend-
8 ed by inserting “and providers of entrepreneurial skills de-
9 velopment programs” after “organizations”.

10 **SEC. 3. REQUIRED LOCAL EMPLOYMENT AND TRAINING AC-**
11 **TIVITIES.**

12 Section 134(c)(2)(A) of the Workforce Innovation
13 and Opportunity Act (29 U.S.C. 3174(c)(2)(A)) is amend-
14 ed—

15 (1) in clause (iv)—
16 (A) in subclause (I)—
17 (i) in item (aa), by striking “; and”
18 and inserting a semicolon; and
19 (ii) by adding at the end the fol-
20 lowing:

21 “(cc) provision of informa-
22 tion on entrepreneurship, as ap-
23 propriate; and”;

24 (B) in subclause (II), by adding “and”
25 after the semicolon; and

1 (C) by adding at the end the following:

2 “(III) referral to microenterprise

3 services, as appropriate;”;

4 (2) in clause (vi)—

5 (A) in subclause (I), by inserting “, which

6 may include resources to support entrepreneurship,” after “listings”; and

7 (B) in subclause (III), by inserting “, which may include entrepreneurship opportunities,” after “demand”; and

8 (3) in clause (xiii), by inserting “or entrepreneurial opportunities” after “workplace”.

13 **SEC. 4. EVALUATIONS AND RESEARCH.**

14 Section 169 of the Workforce Innovation and Opportunity Act (29 U.S.C. 3224) is amended—

16 (1) in subsection (b)—

17 (A) in paragraph (4)—

18 (i) by redesignating subparagraph (K) as subparagraph (L); and

19 (ii) by inserting after subparagraph (J) the following:

22 “(K) STUDY ON ENTREPRENEURIAL SKILLS DEVELOPMENT PROGRAMS.—The Secretary shall, through a grant or contract, conduct a three-year multistate study on entrepre-

1 neurial skills development programs, which
2 shall include the following:

3 “(i) A review of—
4 “(I) successful practices for de-
5 veloping entrepreneurial skills of indi-
6 viduals;

7 “(II) evidence-based and other
8 best practices for mentoring potential
9 entrepreneurs;

10 “(III) the qualifications needed
11 for skills development providers to
12 successfully develop the entrepre-
13 neurial skills of individuals;

14 “(IV) strategies for engaging em-
15 ployers and other private sector part-
16 ners;

17 “(V) such program outcomes that
18 correlate with entrepreneurial success;

19 “(VI) how such programs suc-
20 cessfully measure the progress of par-
21 ticipants in such programs;

22 “(VII) the extent to which such
23 programs lead to industry recognized
24 credentials;

1 “(VIII) the impact, including the
2 economic impact, of such programs on
3 States and local communities;

4 “(IX) the extent to which such
5 programs affect business development
6 and job creation in States and local
7 communities;

8 “(X) how such programs identify
9 potential program participants' ready-
10 ness for the program; and

11 “(XI) the average earnings of
12 participants who complete such a pro-
13 gram three years after the date of
14 completion of such program.

15 “(ii) Recommendations for States and
16 local communities to expand access to such
17 programs.”; and

18 (B) in paragraph (5)(A), by inserting
19 “which shall include individuals pursuing entre-
20 preneurship,” after “particular service popu-
21 lations.”; and

22 (2) in subsection (c), by striking the third sen-
23 tence and inserting the following: “Such projects
24 may include demonstration and pilot projects relat-
25 ing to promoting self-employment, promoting entre-

1 preneurship, promoting job creation (especially for
2 in-demand industry sectors or occupations), averting
3 dislocations, assisting dislocated farmers, assisting
4 dislocated fishermen, developing career pathways
5 and encouraging advancements, and promoting pub-
6 lic works.”.
