A BILL

To prohibit the United States Postal Service from carrying out a contract for the procurement of next generation

vehicle fleet unless such fleet is at least 75 percent electric or zero emission vehicles, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Green Postal Service
5 Fleet Act of 2022”.

6 **SEC. 2. PROHIBITION ON CARRYING OUT PROCUREMENT**

7 **CONTRACT FOR USPS NEXT GENERAL FLEET.**

8 (a) **IN GENERAL.**—The United States Postal Service
9 may not implement or otherwise carry out the contract,
10 entered into with Oshkosh Defense, for the procurement
11 of postal delivery vehicles unless each purchase of vehicles
12 under such contract is at least 75 percent electric or zero
13 emission vehicles.

14 (b) **COMPLIANCE.**—In carrying out subsection (a),
15 the Postal Service shall comply with chapter 83 of title
16 41, United States Code (popularly known as the Buy
17 American Act), and any applicable Federal labor or civil
18 rights laws.
