1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Congressional Budget
- 3 Office Data Sharing Act".
- 4 SEC. 2. REQUESTS BY CBO OF INFORMATION FROM EXECU-
- 5 TIVE AGENCIES.
- 6 (a) In General.—Section 201(d) of the Congres-
- 7 sional Budget and Impoundment Control Act of 1974 (2
- 8 U.S.C. 601(d)) is amended—
- 9 (1) by striking "The Director is authorized"
- and inserting "(1) The Director is authorized";
- 11 (2) by striking "(other than material the disclo-
- sure of which would be a violation of law)" and in-
- serting "(with or without written agreement) pro-
- vided that the Director maintains the level of con-
- fidentiality required by law of the department, agen-
- cy, establishment, or regulatory agency or commis-
- sion from which it is obtained in accordance with
- section 203(e)"; and
- 19 (3) by adding at the end the following:
- 20 "(2) No provision of law enacted after the date of
- 21 the enactment of the Congressional Budget Office Data
- 22 Sharing Act shall be construed to supersede, limit, or oth-
- 23 erwise modify the authority of the Director to obtain any
- 24 material under this subsection unless such provision spe-
- 25 cifically provides, by specific reference to this paragraph,

- 1 that such authority is to be superseded, limited, or other-
- 2 wise modified.".
- 3 (b) Report.—Not later than one year after the date
- 4 of the enactment of this Act, the Director of the Congres-
- 5 sional Budget Office shall submit, to the chairs of the
- 6 Committees on the Budget of the House of Representa-
- 7 tives and the Senate, a report listing any request for infor-
- 8 mation pursuant to a written agreement under section
- 9 201(d) of the Congressional Budget and Impoundment
- 10 Control Act of 1974 (2 U.S.C. 601(d)), as amended by
- 11 subsection (a) of this Act, made to any department, agen-
- 12 cy, or establishment of the executive branch of Govern-
- 13 ment or any regulatory agency or commission of the Gov-
- 14 ernment and any challenges faced accessing information
- 15 under such section.
