## A BILL

To direct the Librarian of Congress to establish a program in the American Folklife Center to collect video and audio recordings of personal histories and testimonials of those affected by the COVID–19 pandemic, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “COVID–19 Oral His-  
5 tory Project Act”.

1 **SEC. 2. ESTABLISHMENT OF PROGRAM AT AMERICAN**  
2 **FOLKLIFE CENTER TO COLLECT VIDEO AND**  
3 **AUDIO RECORDING OF HISTORIES OF THE**  
4 **COVID-19 PANDEMIC.**

5 (a) IN GENERAL.—The Librarian of Congress shall  
6 establish an oral history program in the American Folklife  
7 Center at the Library of Congress to collect and make  
8 publicly available in a digital format individual stories of  
9 events and experiences during the COVID-19 pandemic  
10 in the United States. In carrying out the program, the  
11 Librarian shall—

12 (1) collect video and audio recordings of per-  
13 sonal histories and testimonials of those who were  
14 affected by the COVID-19 pandemic, such as first  
15 responders and health care workers, individuals who  
16 survived the disease, family members of those who  
17 passed away from the disease, individuals who were  
18 repatriated from other countries or from cruise  
19 ships, individuals with major life events affected by  
20 responding to the outbreak, as well as any other in-  
21 dividuals whose lives were altered;

22 (2) create a collection of the recordings ob-  
23 tained (including a catalog and index) which will be  
24 available for public use through the digital collec-  
25 tions of the Library of Congress and such other

1 methods as the Librarian considers appropriate to  
2 the extent feasible subject to available resources; and

3 (3) solicit, collect, and make available in a dig-  
4 ital format written materials (such as letters and  
5 diaries) relevant to the personal histories of health  
6 care workers and first responders who served during  
7 the COVID–19 pandemic and to catalog such mate-  
8 rials in a manner the Librarian considers appro-  
9 priate, consistent with and complimentary to the ef-  
10 forts described in paragraphs (1) and (2).

11 (b) USE OF AND CONSULTATION WITH OTHER ENTI-  
12 TIES.—The Librarian may carry out the activities de-  
13 scribed in paragraphs (1) and (3) of subsection (a)  
14 through agreements and partnerships entered into with  
15 other government and private entities, including through  
16 collaboration with existing archival and oral history pro-  
17 grams throughout the United States, and may otherwise  
18 consult with interested persons (within the limits of avail-  
19 able resources) and develop appropriate guidelines and ar-  
20 rangements for soliciting, acquiring, and making available  
21 recordings under the program under this Act.

22 (c) TIMING.—

23 (1) INITIATION.—As soon as practicable after  
24 the enactment of this Act, the Librarian shall begin

1 collecting video and audio recordings under sub-  
2 section (a)(1).

3 (2) SUNSET.—The authority of the Librarian to  
4 collect video and audio recordings under subsection  
5 (a)(1) shall terminate upon the expiration of the 5-  
6 year period which begins on the date of the enact-  
7 ment of this Act.

8 **SEC. 3. PRIVATE SUPPORT.**

9 (a) ACCEPTANCE OF DONATIONS.—The Librarian of  
10 Congress may solicit and accept donations of funds and  
11 in-kind contributions to carry out the oral history program  
12 under section 2.

13 (b) ESTABLISHMENT OF SEPARATE GIFT AC-  
14 COUNT.—There is established in the Treasury (among the  
15 accounts of the Library of Congress) a gift account for  
16 the oral history program under section 2.

17 (c) DEDICATION OF FUNDS.—Notwithstanding any  
18 other provision of law—

19 (1) any funds donated to the Librarian of Con-  
20 gress to carry out the oral history program under  
21 section 2 shall be deposited entirely into the gift ac-  
22 count established under subsection (b);

23 (2) the funds contained in such account shall be  
24 used solely to carry out the oral history program  
25 under section 2; and

1           (3) the Librarian may not deposit into such ac-  
2           count any funds donated to the Librarian which are  
3           not donated for the exclusive purpose of carrying out  
4           the program under section 2.

5 **SEC. 4. AUTHORIZATION OF APPROPRIATIONS.**

6           (a) AUTHORIZATION.—There are authorized to be ap-  
7           propriated to carry out this Act—

8                 (1) \$4,100,000 for fiscal year 2022; and

9                 (2) such sums as may be necessary for each  
10           succeeding fiscal year.

11           (b) CONTINUING AVAILABILITY OF FUNDS.—Any  
12           amount appropriated pursuant to the authorization under  
13           this section shall remain available until expended.
