Mr. PERRY (for himself, Mrs. MILLER of Illinois, Mr. GOOD of Virginia, Mr. GARCIA of California, and Mrs. BOEBERT) introduced the following bill; which was referred to the Committee on Foreign Affairs, and in addition to the Committees on Financial Services, and the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To codify Executive Order 13876, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Restoring Maximum
5 Pressure on Iranian Terrorists Act”.

6 **SEC. 2. ENACTMENT OF EXECUTIVE ORDER 13876.**

7 (a) IN GENERAL.—The provisions of Executive Order
8 13876 (84 Fed. Reg. 30573; relating to imposing sanc-
9 tions with respect to Iran), as in effect on June 24, 2019,

1 other than section 7 of such Executive Order, are enacted
2 into law.

3 (b) PUBLICATION.—In publishing this Act in slip
4 form and in the United States Statutes at Large pursuant
5 to section 112 of title 1, United States Code, the Archivist
6 of the United States shall include after the date of ap-
7 proval at the end an appendix setting forth the text of
8 the Executive order referred to in subsection (a), as in
9 effect on June 24, 2019.

10 **SEC. 3. EVASION OF SANCTIONS.**

11 (a) IN GENERAL.—The following actions are hereby
12 prohibited:

13 (1) Any transaction by a United States person
14 or within the United States that evades or avoids,
15 has the purpose of evading or avoiding, causes a vio-
16 lation of, or attempts to violate the prohibitions set
17 forth in the Executive order referred to in section
18 2(a) and enacted into law by such section.

19 (2) Any conspiracy formed to violate any of the
20 prohibitions set forth in the Executive order referred
21 to in section 2(a) and enacted into law by such sec-
22 tion.

23 (b) PENALTIES.—The President is authorized to
24 apply the penalties provided for in subsections (b) and (c)
25 of section 206 of the International Emergency Economic

1 Powers Act (50 U.S.C. 1705) with respect to a person
2 that knowingly violates, attempts to violate, conspires to
3 violate, or causes a violation of regulations promulgated
4 to carry out the Executive order referred to in section 2(a)
5 and enacted into law by such section to the same extent
6 that such penalties apply to a person that knowingly com-
7 mits an unlawful act described in section 206(a) of such
8 Act.

9 **SEC. 4. CONTINUING SANCTIONS AGAINST ENTITIES DES-**
10 **IGNATED UNDER EXECUTIVE ORDER 13876.**

11 All entities designated under Executive Order 13876
12 (84 Fed. Reg. 30573; relating to imposing sanctions with
13 respect to Iran) on the following dates shall continue to
14 be sanctioned pursuant to such designations, as in effect
15 on such respective dates:

- 16 (1) July 31, 2019.
17 (2) November 4, 2019.
18 (3) January 10, 2020.
19 (4) February 20, 2020.
20 (5) November 18, 2020.
