A BILL

To amend the Servicemembers Civil Relief Act to require public lodging establishments to waive minimum age requirements for members of the Armed Forces.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "Hotels for Heroes Act
5 of 2022".

1 **SEC. 2. WAIVER OF MINIMUM AGE REQUIREMENTS IN PUB-**
2 **LIC LODGING ESTABLISHMENTS FOR MEM-**
3 **BERS OF ARMED FORCES.**

4 (a) WAIVER.—Title VII of the Servicemembers Civil
5 Relief Act (50 U.S.C. 4021 et seq.) is amended by adding
6 at the end the following new section:

7 **“SEC. 708. WAIVER OF MINIMUM AGE REQUIREMENTS IN**
8 **PUBLIC LODGING ESTABLISHMENTS.**

9 “(a) WAIVER.—A public lodging establishment shall
10 waive any minimum age requirement to obtain accommo-
11 dation at such establishment for a member of the Armed
12 Forces who presents a valid identification card issued by
13 the Armed Force of such member and seeks to obtain ac-
14 commodation at such establishment while—

15 “(1) under military orders (as defined in sec-
16 tion 305); or

17 “(2) on authorized military leave.

18 “(b) PENALTY.—Whoever knowingly violates sub-
19 section (a) shall be fined under title 18, United States
20 Code.

21 “(c) PUBLIC LODGING ESTABLISHMENT DEFINED.—
22 In this section, the term ‘public lodging establishment’ in-
23 cludes any inn, hotel, motel, or other establishment that
24 provides lodging to transient guests, other than an estab-
25 lishment located within a building that contains not more
26 than five rooms for rent or hire and that is actually occu-

1 pied by the proprietor of such establishment as the resi-
2 dence of such proprietor.”.

3 (b) CLERICAL AMENDMENT.—The table of contents
4 for that Act is amended by inserting after the item relat-
5 ing to section 707 the following new item:

 “Sec. 708. Waiver of minimum age requirements in public lodging establish-
 ments.”.
