Mr. MEADOWS introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To develop a report regarding possible duplication of Federal damage assessments, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Federal Disaster As-
5 sistance Coordination Act”.

1 **SEC. 2. REPORT WITH RESPECT TO STREAMLINING FED-**
2 **ERAL DISASTER ASSISTANCE ASSESSMENTS**
3 **AND THE POTENTIAL USES OF EMERGING**
4 **TECHNOLOGIES.**

5 (a) IN GENERAL.—Not later than 1 year after the
6 date of the enactment of this Act, the President, acting
7 through the Administrator of the Federal Emergency
8 Management Agency, and in consultation with the Council
9 of the Inspectors General on Integrity and Efficiency,
10 shall convene a working group on a regular basis with the
11 Secretary of the Department of Labor, the Director of the
12 Office of Management and Budget, the Secretary of
13 Health and Human Service, the Administrator of the
14 Small Business Administration, the Secretary of the De-
15 partment of Transportation, the Assistant Secretary of
16 Commerce for Economic Development, and other appro-
17 priate agencies as the Administrator considers necessary,
18 to develop—

19 (1) a report that identifies and describes the
20 potential areas of duplication or fragmentation in
21 post-disaster declarations in Federal assessments of
22 data collection methods and data collected and pro-
23 gram delivery after post-disaster declarations;

24 (2) determine the applicability of having one
25 Federal agency make the assessments for all agen-
26 cies;

1 (3) identify potential emerging technologies,
2 such as Unmanned Aircraft Systems, consistent with
3 the requirements established in Public Law 115–87,
4 to expedite the administration of disaster assistance
5 assessments; and

6 (4) develop and submit to the Committee on
7 Transportation and Infrastructure of the House of
8 Representatives and the Committee on Homeland
9 Security and Governmental Affairs of the Senate a
10 report on the findings of the working group that
11 may include recommendations.

12 (b) PUBLIC AVAILABILITY.—The report developed
13 under subsection (a) shall be made available to the public
14 and posted on the internet website of the Federal Emer-
15 gency Management Agency—

16 (1) in pre-compressed, easily downloadable
17 versions that are made available in all appropriate
18 formats; and

19 (2) in machine-readable format, if applicable.

20 (c) SOURCES OF INFORMATION.—In preparing such
21 report, any publication, database, web-based resource, and
22 any information compiled by any government agency, non-
23 governmental organization, or other entity that is made
24 available may be used.

1 **SEC. 3. BRIEFING.**

2 Not later than 2 years after the date of the enact-
3 ment of this Act, the Administrator of the Federal Emer-
4 gency Management Agency, or a designee, and a member
5 of the Council of the Inspectors General on Integrity and
6 Efficiency, or a designee, shall brief, upon request, the ap-
7 propriate congressional committees on the report's find-
8 ings and any recommendations made in the report, if ap-
9 plicable.
