Mr. TAKANO introduced the following bill; which was referred to the

A BILL

To direct the Secretary of Veterans Affairs to create fact sheets, for veterans and for survivors of veterans, that compare benefits and compensation, to such individuals under laws administered by the Secretary, to monthly insurance benefits under title II of the Social Security Act, and to supplemental security income under title XVI of the Social Security Act.

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Information on Federal
3 Resources for Military Servicemembers Act” or the “IN-
4 FORMS Act”.

5 **SEC. 2. FACT SHEETS REGARDING VA AND SOCIAL SECU-
6 RITY BENEFITS AND COMPENSATION.**

7 (a) ESTABLISHMENT.—Not later than six months
8 after the date of the enactment of this Act, the Secretary
9 of Veterans Affairs, after consultation with the Commis-
10 sioner of the Social Security Administration and stake-
11 holders (including veterans service organizations), shall
12 create fact sheets, one for veterans and one for survivors
13 of deceased veterans, that compares, for such individ-
14 uals—

15 (1) benefits and compensation (including a pen-
16 sion) under laws administered by the Secretary;

17 (2) monthly insurance benefits under title II of
18 the Social Security Act (42 U.S.C. 401 et seq.); and

19 (3) supplemental security income under title
20 XVI of the Social Security Act (42 U.S.C. 1381 et
21 seq.).

22 (b) ELEMENTS.—A fact sheet created under sub-
23 section (a) shall include, with respect to such benefits and
24 compensation, monthly insurance benefits, and supple-
25 mental security income, the following:

26 (1) Differences in eligibility requirements.

1 (2) Filing requirements.

2 (3) How to apply.

3 (4) Sources of additional information or assist-
4 ance in applications.

5 (c) PROVISION.—Not later than three months after
6 creating a fact sheet under subsection (a), the Secretary
7 shall provide a copy thereof to an individual whenever the
8 Secretary—

9 (1) receives from such individual—

10 (A) an initial claim for a benefit or com-
11 pensation; or

12 (B) a claim for an increase to a benefit or
13 compensation; or

14 (2) notifies such individual that the Secretary
15 has denied a claim for, or decreased the amount of,
16 a benefit or compensation.

17 (d) ANNUAL UPDATES.—The Secretary shall update
18 a fact sheet created under subsection (a), to reflect
19 amendments to laws described in such subsection, not less
20 than once annually.
