## A BILL

To reauthorize tuition assistance programs under the District  
of Columbia College Access Act of 1999.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REAUTHORIZATION OF TUITION ASSISTANCE**

4 **PROGRAMS.**

5 (a) REAUTHORIZATION.—Section 7 of the District of  
6 Columbia College Access Act of 1999 (sec. 38–2706, D.C.  
7 Official Code) is amended to read as follows:

8 **“SEC. 7. AUTHORIZATION OF APPROPRIATIONS.**

9 “There are authorized to be appropriated to the Dis-  
10 trict of Columbia to carry out section 3 and section 5 an

1 aggregate amount of \$40,000,000 for each of the fiscal  
2 years 2019 through 2023. Such funds shall remain avail-  
3 able until expended.”.

4 (b) CONFORMING AMENDMENT RELATING TO RE-  
5 Ductions IN AMOUNTS FOR INSUFFICIENT APPROPRIA-  
6 TIONS.—

7 (1) PUBLIC SCHOOL PROGRAM.—Section  
8 3(b)(1) of such Act (sec. 38–2702(b)(1), D.C. Offi-  
9 cial Code) is amended by striking “If the funds” and  
10 all that follows through “are insufficient” and in-  
11 sserting “If the funds appropriated pursuant to sec-  
12 tion 7 are insufficient”.

13 (2) PRIVATE SCHOOL PROGRAM.—Section  
14 5(b)(1) of such Act (sec. 38–2704(b)(1), D.C. Offi-  
15 cial Code) is amended by striking “If the funds” and  
16 all that follows through “are insufficient” and in-  
17 sserting “If the funds appropriated pursuant to sec-  
18 tion 7 are insufficient”.

19 (c) CONFORMING AMENDMENT RELATING TO EX-  
20 Pired AUTHORIZATIONS.—

21 (1) PUBLIC SCHOOL PROGRAM.—Section 3 of  
22 such Act (sec. 38–2702, D.C. Official Code) is  
23 amended by striking subsection (i).

1           (2) PRIVATE SCHOOL PROGRAM.—Section 5 of  
2 such Act (sec. 38–2704, D.C. Official Code) is  
3 amended by striking subsection (f).
