# **A BILL**

To amend the Federal Oil and Gas Royalty Management Act of 1982 to improve the management of royalties from oil and gas leases, and for other purposes.

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Royalty Resiliency Act”.*

3 **SEC. 2. DETERMINATION OF ALLOCATIONS OF PRODUCTION**  
4 **FOR UNITS AND COMMUNITIZATION**  
5 **AGREEMENTS.**

6 *Section 111(j) of the Federal Oil and Gas Royalty*  
7 *Management Act of 1982 (30 U.S.C. 1721(j)), as amended*  
8 *by the Federal Oil and Gas Royalty Simplification and*  
9 *Fairness Act of 1996 (Public Law 104–185), is amended*  
10 *to read as follows:*

11 *“(j) The Secretary shall issue all determinations of al-*  
12 *locations of production for units and communitization*  
13 *agreements within 120 days of a request for determination.*  
14 *Until the Secretary issues the determination, the lessee or*  
15 *its designee of a lease in a unit or communitization agree-*  
16 *ment shall report and pay royalties on oil and gas produc-*  
17 *tion for each production month in accordance with the*  
18 *terms of the proposed allocation of production for the unit*  
19 *or communitization agreement. After the Secretary issues*  
20 *the determination, the lessee or its designee shall, as nec-*  
21 *essary, correct such reports and the amount of royalties*  
22 *paid on oil and gas production under the unit or*  
23 *communitization agreement by not later than the end of*  
24 *the third month following the month in which the lessee or*  
25 *its designee receives the determination from the Secretary.*  
26 *Subject to the full and timely monthly payment of royalties*

1 to all parties in accordance with the terms of the proposed  
2 allocation of production for the unit or communitization  
3 agreement, the Secretary shall waive interest due on obliga-  
4 tions subject to the determination until the end of the third  
5 month following the month in which the lessee or its des-  
6 ignee receives the determination from the Secretary. This  
7 subsection shall not apply to unit or communitization agree-  
8 ments containing Indian lands.”.
