## A BILL

To authorize a dedicated transnational repression office within the Department of Homeland Security's Homeland Security Investigations to analyze and monitor transnational repression and related terrorism threats and require Homeland Security Investigations to take actions to prevent transnational repression.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Combating  
3 Transnational Repression Act of 2024”.

4 **SEC. 2. TRANSNATIONAL REPRESSION.**

5 (a) FINDINGS AND SENSE OF CONGRESS REGARDING  
6 TRANSNATIONAL REPRESSION.—

7 (1) FINDINGS.—Congress makes the following  
8 findings:

9 (A) The Department of Homeland Security  
10 (DHS), Homeland Security Investigations  
11 (HSI) National Security Division (NSD), Spe-  
12 cial Interest Investigations Unit (SIIU), col-  
13 laborates with Federal, State, and local part-  
14 ners to investigate allegations of transnational  
15 repression.

16 (B) HSI, through its investigative authori-  
17 ties, works to deter, dismantle, and mitigate  
18 criminal enterprises and hostile foreign govern-  
19 ment actors engaged in transnational repres-  
20 sion.

21 (C) In October 2023, the Government Ac-  
22 countability Office (GAO) published a report  
23 that found agency actions are needed to address  
24 harassment of dissidents and other tactics of  
25 transnational repression in the United States.

(D) According to GAO, several Federal agencies work to address transnational repression, including DHS's Office of Intelligence and Analysis, which works to produce intelligence that support Federal, State, and local government entities to develop protective and support measures in response to threats of transnational repression, as well as DHS's Office of Partnership and Engagement (OPE), which meets with stakeholders and victims of transnational repression to understand the range of transnational repression activities in the United States. For example, DHS hosted a listening session in March 2022 with stakeholders to learn about issues facing communities in the United States. DHS has also issued reporting for State and local law enforcement agencies to raise awareness about acts of transnational repression.

20 (E) DHS's OPE also works to share avail-  
21 able Federal resources to help disrupt threats  
22 of transnational repression against United  
23 States citizens, with Federal, State, local, Trib-  
24 al, and international partners so they coordi-

1 nate countering acts of transnational repression  
2 and preparing best practices.

3 (2) SENSE OF CONGRESS.—It is the sense of  
4 Congress that—

5 (A) transnational repression and related  
6 terrorism threats by a foreign government or an  
7 agent of a foreign government to target individ-  
8 uals in the United States and persons outside  
9 of the United States are real and growing;

10 (B) agents acting on behalf of hostile for-  
11 eign governments employ a range of  
12 transnational repression tactics, including mak-  
13 ing threats, intimidation, harassment, surveil-  
14 lance, stalking, silencing, and planning physical  
15 harm or the kidnapping of individuals in the  
16 United States; and

17 (C) the Department of Homeland Security  
18 must take steps to recognize, assess, and help  
19 address this threat, thereby reducing risks to  
20 the people of the United States.

21 (b) OFFICE TO COMBAT TRANSNATIONAL REPRES-  
22 SION.—

23 (1) IN GENERAL.—Subtitle H of title VIII of  
24 the Homeland Security Act of 2002 (6 U.S.C. 451

1       et seq.) is amended by adding at the end the fol-  
2       lowing new section:

3       **“SEC. 890E. TRANSNATIONAL REPRESSION.**

4       “(a) OFFICE TO ANALYZE, MONITOR, AND INVES-  
5       TIGATE TRANSNATIONAL REPRESSION.—

6           “(1) IN GENERAL.—There is established an of-  
7       fice, to be known as the ‘Transnational Repression  
8       Office’ (in this section referred to as the ‘Office’), in  
9       the National Security Division of Homeland Security  
10      Investigations, which shall be responsible for ana-  
11      lyzing and monitoring transnational repression and  
12      related terrorism threats.

13       “(2) DIRECTOR OF THE OFFICE.—

14           “(A) APPOINTMENT OF DIRECTOR.—The  
15       head of the Office shall be the Director of the  
16       Transnational Repression Office, who shall be  
17       appointed by the Director of Homeland Secu-  
18       rity Investigations.

19           “(B) REPORTING.—The Director of the  
20       Transnational Repression Office shall report to  
21       the Secretary and the Director of Homeland  
22       Security Investigations regarding all adminis-  
23       trative, operational, and security matters of the  
24       Office.

1                 “(3) STAFFING.—The Director of Homeland  
2                 Security Investigations shall ensure the Office—

3                         “(A) has a sufficient number of employees  
4                 to perform required duties; and

5                         “(B) has at least one employee dedicated  
6                 to ensuring compliance with privacy laws and  
7                 regulations.

8                 “(4) DETAILEES AUTHORIZED.—The Office  
9                 may accept and employ detailees with expertise in  
10                 countering transnational repression and related ter-  
11                 rorism threats or related fields from any element of  
12                 the intelligence community, or any other Federal  
13                 agency the Director of the Transnational Repression  
14                 Office determines appropriate, with or without reim-  
15                 bursement, consistent with applicable laws and regu-  
16                 lations regarding such employees.

17                 “(5) INFORMATION SHARING.—The Office shall  
18                 review information relating to transnational repres-  
19                 sion and related terrorism threats that is gathered  
20                 by Federal, State, local, Tribal, and territorial part-  
21                 ners, and the National Network of Fusion Centers,  
22                 and incorporate such information, as appropriate,  
23                 into the Office’s own information relating to  
24                 transnational repression and related terrorism  
25                 threats. The Office shall ensure the dissemination to

1       Federal, State, local, Tribal, and territorial partners,  
2       and the National Network of Fusion Centers, of in-  
3       formation related to transnational repression and re-  
4       lated terrorism threats.

5                 “(6) HOMELAND SECURITY ASSESSMENT ON  
6       TRANSNATIONAL REPRESSION.—

7                 “(A) ANNUAL ASSESSMENTS.—Not later  
8       than 180 days after the date of the enactment  
9       of this section and annually thereafter for ten  
10      years, the Director of Homeland Security Inves-  
11      tigations, acting through the Director of the  
12      Transnational Repression Office, shall submit  
13      to the Committee on Homeland Security of the  
14      House of Representatives and the Committee  
15      on Homeland Security and Governmental Af-  
16      fairs of the Senate a report that assesses inci-  
17      dents of transnational repression and related  
18      terrorism threats during the immediately pre-  
19      ceding 12 months.

20                 “(B) CONTENTS.—Each assessment sub-  
21      mitted under subparagraph (A) shall also in-  
22      clude the following:

23                         “(i) An analysis attempted incidents  
24      of transnational repression and related ter-  
25      rorism threats.

1                     “(ii) A quantitative analysis of  
2 transnational repression and related ter-  
3 rrorism threats, including the number of in-  
4 dividuals responsible for or associated with  
5 such transnational repression or related  
6 terrorism threats, and an identification of  
7 the country of citizenship or nationality of  
8 each such individual, and the roles of the  
9 foreign governments of such countries in  
10 enabling, preventing, mitigating, and re-  
11 sponding to transnational repression and  
12 related terrorism threats.

13                     “(iii) Subject to appropriate protec-  
14 tions for sensitive information regarding  
15 law enforcement investigations and oper-  
16 ations, a description of efforts by the De-  
17 partment to disrupt through investigation  
18 transnational repression and related ter-  
19 rrorism threats.

20                     “(iv) Any other matters the Director  
21 of Homeland Security Investigations deter-  
22 mines relevant.

23                     “(C) FORM.—Each assessment under sub-  
24 paragraph (A) shall be submitted in unclassi-  
25 fied form, but may include a classified annex

1           only for the protection of intelligence sources  
2           and methods relating to the matters contained  
3           in each such assessment. The Director of  
4           Homeland Security Investigations shall post on  
5           a publicly available website of Homeland Secu-  
6           rity Investigations the unclassified portion of  
7           each such assessment.

8           “(7) SUNSET.—The Office shall terminate on  
9           the date that is ten years after the date of the enact-  
10          ment of this section.

11          “(b) RESEARCH.—Not later than one year after the  
12         date of the enactment of this section, the Secretary, in  
13         coordination with the Under Secretary for Science and  
14         Technology of the Department, the Director of the  
15         Transnational Repression Office, and the Director of  
16         Homeland Security Investigations, shall, to the extent  
17         practicable, carry out research and development, including  
18         operational testing, of technologies and techniques for en-  
19         hancing the Department’s security and situational aware-  
20         ness support to Federal, State, local, Tribal, and terri-  
21         torial officials relating to combating transnational repres-  
22         sion and related terrorism threats, in accordance with ap-  
23         plicable constitutional, privacy, civil rights, and civil lib-  
24         erties protections.

25          “(c) DEFINITIONS.—In this section:

1               “(1) AGENT OF A FOREIGN GOVERNMENT.—

2     The term ‘agent of a foreign government’ means an  
3     individual or entity that operates subject to the di-  
4     rection or control of—

5               “(A) a foreign government; or

6               “(B) an official or entity of such foreign  
7     government.

8               “(2) FOREIGN GOVERNMENT.—The term ‘for-  
9     eign government’ means the government of a foreign  
10    country.

11               “(3) FUSION CENTER.—The term ‘fusion cen-  
12     ter’ has the meaning given such term in subsection  
13     (j) of section 210A of the Homeland Security Act of  
14     2002 (6 U.S.C. 124h).

15               “(4) INTELLIGENCE COMMUNITY.—The term  
16     ‘intelligence community’ has the meaning given such  
17     term in section 3(4) of the National Security Act of  
18     1947 (50 U.S.C. 3003(4)).

19               “(5) NATIONAL NETWORK OF FUSION CEN-  
20     TERS.—The term ‘National Network of Fusion Cen-  
21     ters’ means a decentralized arrangement of fusion  
22     centers intended to enhance individual State and  
23     urban area fusion centers’ ability to leverage the ca-  
24     pabilities and expertise of all such fusion centers for

1       the purpose of enhancing analysis and homeland se-  
2       curity information sharing nationally.

3           “(6) TRANSNATIONAL REPRESSION.—The term  
4       ‘transnational repression’ means an action of a for-  
5       eign government or an agent of a foreign govern-  
6       ment that satisfies each of the following:

7           “(A) The action involves—

8              “(i) any effort intended to coerce, har-  
9       ass, or digitally or physically threaten, in-  
10       cluding by force or reasonable fear of  
11       death or serious bodily injury or imprison-  
12       ment of a person or an immediate family  
13       member of a person, a person to take an  
14       action in the interest of such a foreign gov-  
15       ernment;

16              “(ii) any effort intended to harass or  
17       coerce, including by force or fear, a person  
18       to forebear from exercising their First  
19       Amendment rights or any other right guar-  
20       anteed to the person by the Constitution or  
21       laws of the United States, or to retaliate  
22       against a person for having exercised such  
23       a right;

24              “(iii) an extrajudicial killing; or

1                         “(iv) any act intended to further the  
2                         efforts specified in clause (i), (ii), or (iii).

3                         “(B) The action is engaged in for or in the  
4                         interests of such a foreign government.

5                         “(C) The action—

6                         “(i) occurs, in whole or in part, in the  
7                         United States; or  
8                         “(ii) is committed against a United  
9                         States person.

10                         “(7) UNITED STATES PERSON.—The term  
11                         ‘United States person’ has the meaning given such  
12                         term in section 1637(d)(10) of the Carl Levin and  
13                         Howard P. ‘Buck’ McKeon National Defense Au-  
14                         thorization Act for Fiscal year 2015 (50 U.S.C.  
15                         1708(d)(10)).”.

16                         (2) CLERICAL AMENDMENT.—The table of con-  
17                         tents in section 1(b) of the Homeland Security Act  
18                         of 2002 is amended by inserting after the item relat-  
19                         ing to section 890D the following new item:

“Sec. 890E. Transnational repression.”.
